



INVITATION TO BID FOR

Supply and Delivery of Class “B” Water Meter Requirements of the SMWD for the 2nd to 4th Qtr. of the Year 2017

1. The Santa Maria Water District, through the Corporate Budget duly approved by the Board of Directors for the year 2017 intends to apply the sum of **Six Million Eight Hundred Ninety Two Thousand Pesos (P 6,892,000.00)** being the Approved Budget for the Contract (ABC) to payments under the contract for “Supply and Delivery of Water Meter Requirements of the SMWD for the 2nd to 4th Qtr. of the year 2017”. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The Santa Maria Water District now invites bids for Four Thousand Fifty Four (4,054) pcs. Class “B” Water Meter ½”. Delivery of the Goods is required within Seven (7) calendar days upon receipt of Purchase Orders. Bidders should have completed, within one (1) year from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act”.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.

4. Interested bidders may obtain further information from Santa Maria Water District and inspect the Bidding Documents at the address given below during office hours, 8:00 AM to 5:00PM.

A complete set of Bidding Documents may be purchased by interested Bidders on **March 22 to 29, 2017** from the address below and upon payment of a nonrefundable fee for the Bidding Documents in the amount of Seven Thousand Pesos (P 7,000.00).

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the nonrefundable fee for the Bidding Documents not later than the submission of their bids.

5. Bids must be delivered to the address below on or before **April 11, 2017 at 12:00 PM**. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB Clause Error! Reference source not found.**

Bid opening shall be on **April 11, 2017, 1:30 PM** at *Engineer’s Office, SMWD, J.P. Rizal St., Poblacion, Santa Maria, Bulacan*. Bids will be opened in the presence of the Bidders’ representatives who choose to attend at the address below. Late bids shall not be accepted.
