The Santa Maria Water District (SMWD) hereinafter referred to as “the Purchaser”, through its Bids and Awards Committee (BAC), would like to invite interested Bidder/Supplier to submit Proposal for the project “**Repainting of Storage Tanks and Repair of its Level Indicator**” through Alternative Mode of Procurement – Small Value Procurement (Sec. 53.9 of R.A. No. 9184) with Approved Budget for the Contract (ABC) of Three Hundred Thirty Thousand Three Hundred Pesos only (**P330,300.00**).

All items listed under the Purchaser’s Program of Work must be complied on a pass-fail basis. Failure to meet any one of the requirements will result to rejection. Likewise, it is understood that Purchaser’s specifications are minimum requirements. The Bidder/Contractor may offer higher specifications or additional items, if any.

Procurement procedures will be conducted in accordance with the provisions of the Implementing Rules and Regulations (IRR) of Republic Act No. 9184 (Government Procurement Reform Act).

It is the intent of the Purchaser to evaluate the proposals submitted by the interested Bidder/Supplier and the award will be made to the proposal/quotation resulting in the overall lowest cost and conditions must be most advantageous to the Purchaser. Contract Award will be made to the lowest evaluated proposal/quotation meeting the entity’s standard/requirements.

Likewise, in accordance with Section 54.6 and Appendix A of Annex "H" (Consolidated Guidelines for the Alternative Methods of Procurement) of the IRR of RA No. 9184, the supplier shall provide the following documentary requirements as a **condition for award** of the contract:

All quotations may be typewritten or handwritten and may be placed in sealed envelope marked “**(Repainting of Storage Tanks and Repair of its Level Indicator – GULOD)**” (RFQ No. 2017-0054) and must be delivered on or before **October 4, 2017, 11:59AM** at the SMWD main office (BAC Secretariat). It may also be sent thru email on our official email address at [smwdbulacan@yahoo.com](mailto:smwdbulacan@yahoo.com) on the specified time stated above and address to the BAC Secretariat, Charito S. Fernando and /or Procurement Assistant, Randy S. Sazon.

Quotations shall be valid for thirty (30) calendar days from the deadline of submission of the same.

The contractor should inform the purchaser at least five 3 to 5 days before the repainting & repair stated of the above pump station. The Purchaser shall have the right to reject or to return the equipment or items/fittings that will be declared defective. The delivery will be made only during working days from 8:00 AM to 5:00 PM.

DELIVERY SITE: On-site.

The prospective supplier shall submit the following:

The Santa Maria Water District reserves the right to accept or reject any proposal, and to annul the procurement process and reject all proposal or quotations at any time prior to Contract award, without thereby incurring any liability to the affected contractor or party. SMWD also reserves the right to waive any required formality in the proposals received, and select the proposal which it determines to be the most advantageous to the government.
