BAC Resolution Declaring Second Failure of Bidding

RESOLUTION NO. BCR 2018-001

WHEREAS, in accordance with the pertinent provisions of the revised IRR of RA No. 9184, the SMWD-BAC conducted a re-bidding with re-advertisement and/or re-posting of the Invitation to Bid for the above stated project with an Approved Budget for the Contract (ABC) amounting to One million Two Hundred Seventy Thousand Seven Hundred Thirty Seven Pesos and 60/100 (P 1,270,737.60) in website of Philippine Government Electronic Procurement System (Philgeps), SMWD's website and in a conspicuous place in the premise of SMWD ;

WHEREAS, likewise in furtherance with the provisions of RA No. 9184, representatives from Commission on Audit (COA) as well as observers from private sector were re- invited to observe and witness the stages of re-bidding for the said project;

WHEREAS, the deadline for submission of Bids was set on or before January 24, 2018 at 12:00 N.N;

WHEREAS, again no prospective security services provider or agency responded or submitted Bidding Documents on the specified date and time of submission, not even a letter of intent and application for eligibility was submitted to the BAC Secretariat;

WHEREAS, it is stated in IRR of RA 9184 Rule X, Section 35.1 that one of the prerequisites for the declaration of second failure of bidding is if no bids are received on the specified date of submission;

WHEREAS, it is also stated in IRR of RA 9184 Rule X, Section 35.3 that based on the findings of the BAC with the cause of the Failure of Bidding, the BAC shall revise the terms, conditions, and specifications, and if necessary, adjust the ABC, subject to the approval of the HOPE;

WHEREAS, it is stated in IRR Section 35.5 that should there occur a second failure of bidding, the Procuring Entity may resort to negotiated procurement;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVED as it is hereby RESOLVED:

- a) To declare second failure of bidding for the project, "Supply of Security Services in Various SMWD Offices for a period of one (1) Year."
- b) To adjust the Approved Budget of the contract based on minimum wage rate of a guard on a twelve hours work per day subject for review and verification of the BAC members.
- c) To revise the amount stated in PPMP as well as in the approved Annual Procurement Plan based on the adjusted budget for the contract subject to the approval of the Head of the Procuring Entity.
- d) To resort to Alternative Mode of Procurement under Negotiated Procurement for the execution of this project.






