CONTRACT AGREEMENT No. CA2018-03-005

THIS AGREEMENT, made this 12th day of March, 2018 between SANTA. MARIA WATER DISTRICT with principal office address at No. M. de Leon St., Poblacion, Santa Maria, Bulacan (hereinafter called the "Entity") and CONCORD METALS, INC. with principal office address at No. 54 C. Cordero St., bet. 5th and 6th Ave., Grace Park, Caloocan City (hereinafter called the "Supplier").

WHEREAS, the Entity is desirous that the Supplier execute the project, "SUPPLY AND DELIVERY OF CAST IRON (CI) AND DUCTILE IRON (DI) FITTINGS REQUIREMENTS OF THE SMWD FOR THE YEAR 2018" (hereinafter called "the Works") and the Entity has accepted the Bid for <u>ONE MILLION SEVEN HUNDRED THIRTY FOUR</u> <u>THOUSAND THREE HUNDRED PESOS AND 70/100 (1,734,300.70)</u> by the Supplier for the execution and completion of such works and the remedying of any defects therein.

- 3. In consideration of the payments to be made by the Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Entity to provide the goods and services and to remedy defects therein in conformity in all respects with the provisions of the Contract.
- 4. The Entity hereby covenants to pay the Supplier in consideration of the provision of the goods and services and the remedying of defects wherein, the Contract Price or such other sum as may become payable under the provisions of this Contract at the time and in the manner prescribed by this Contract.
