Supply and Delivery of Calcium Hypochlorite of the SMWD for the CY 2018

BAC Resolution Declaring LCRB and Recommending Approval

RESOLUTION NO. BCR2018-031-PB

WHEREAS, the Santa Maria Water District BAC initiated second bidding for the above stated project. The first failure of bidding for the project was declared on April 10, 2018 and recommendation for second bidding has been approved thru BAC Resolution No. 2018-024-PB.

WHEREAS, the BAC secretariat re-posted In PhilGeps and SMWD's website an invitation to Bid for the above stated project for the period April 12 to 19, 2018. The same invitation was sent to three (3) observers and was also posted at conspicuous premise of the Santa Maria Water District's office on the same period;

WHEREAS, in response to the said invitation, four (4) chemical suppliers purchased bidding documents and submitted the same on April 23, 2018, the specified date for submission and opening of bids in the following time sequences;

WHEREAS, the BAC disqualified the bidder, **The Alpha Enterprise**, in participating in the bidding for the reason that it did not follow the instructions with regards the sealing of envelope (BDS ITB Clause 20.3);

WHEREAS, the SMWD BAC upon thorough evaluation and checking of all the eligibility and technical documents declared Chemical Research Products Industrial Sales, Inc., Uptown Industrial Sales, Inc. and Jedaric Chemical Co., Inc. as eligible bidders, the bidding documents of the eligible bidders, were opened and passed the preliminary examination of bids. However the bid of Chemical Research Products Industrial Sales, Inc. was proclaimed as the lowest bid as read;


WHEREAS, on May 7, 2018, the result of the Chlorine Analysis of calcium hypochlorite, "Nicolon", offered by the bidder has been received by the BAC Secretariat. It was learned from the result that the product has seventy one percent (71%) available chlorine. With the results of the post qualification and chlorine analysis, the bidder, Chemical Research Products Industrial Sales, Inc. has been found to be responsive and thus declared as the Lowest Calculated Responsive Bid;


NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVED as it is hereby RESOLVED:




