The bidder for the first above stated project was **E. C. Laforteza Construction** represented by Ms. Leah Dominic C. Plaza, Materials Engineer of E.C. Laforteza Construction. She submitted bidding documents in one (1) Mother Envelope properly sealed and marked on 11.55 AM that day, July 18, 2018;
- WHEREAS, the bidder for the second above stated project was **Aqua Haus, Inc.** It also downloaded the bidding documents from Philgeps website, paid the fee for the documents then submitted the same documents to the BAC secretariat properly sealed and marked on 11:30 AM of that day also.
