CONTRACT AGREEMENT

THIS AGREEMENT, made this 23rd day of May 2018 between SANTA. MARIA WATER DISTRICT with principal office address at No. 3 M. de Leon St., Poblacion, Santa Maria, Bulacan (hereinafter called the "Entity") and CHEMICAL RESEARCH PRODUCTS INDUSTRIAL SALES INC., with principal office address at No. 1606-A East Tower, Philippine Stock Exchange Center, Exchange Road, Ortigas Center, Pasig City, the "Supplier").

WHEREAS, the Entity is desirous that the Supplier execute the project, "SUPPLY AND DELIVERY OF CALCIUM HYPOCHLORITE FOR SMWD FOR THE CY YEAR 2018" (hereinafter called "the Works") and the Entity has accepted the Bid for **SIX HUNDRED SEVENTY SIX THOUSAND PESOS (676,000.00)** by the Supplier for the execution and completion of such works and the remedying of any defects therein.


NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
2. The following documents shall be attached, deemed to form, and be read and construed as part of this Agreement, viz:
 - (a) the Bid Form and the Price Schedule submitted by the Bidder;
 - (b) the Schedule of Requirements;
 - (c) the Technical Specifications;
 - (d) the General Conditions of Contract;
 - (e) the Special Conditions of Contract; and
 - (f) the Entity's Notification of Award;
3. In consideration of the payments to be made by the Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Entity to provide the goods and services and to remedy defects therein in conformity in all respects with the provisions of the Contract.
4. The Entity hereby covenants to pay the Supplier in consideration of the provision of the goods and services and the remedying of defects wherein, the Contract Price or such other sum as may become payable under the provisions of this Contract at the time and in the manner prescribed by this Contract.




