



CONTRACT AGREEMENT

CA 2018-07-014

THIS AGREEMENT, made this 11th day of July, 2018 between SANTA. MARIA WATER DISTRICT with principal office address at No. 3 M. de Leon St., Poblacion, Santa Maria, Bulacan (hereinafter called the "Entity") and E.C. LAFORTEZA CONSTRUCTION with principal office address at Block 13 Lot 7, Commonwealth Avenue, Jordan Plains Subdivision, Phase 3, Novaliches, Quezon City (hereinafter called the "Contractor").

WHEREAS, the Entity is desirous that the Contractor execute the project, "**A. SUPPLY OF LABOR AND MATERIALS FOR THE REPAINTING AND REHABILITATION OF FIVE (5) PUMP STATIONS OF SANTA MARIA WATER DISTRICT and B. SUPPLY OF LABOR AND MATERIALS FOR THE PAINTING OF LOGO FOR SIX (6) PUMP STATIONS OF SANTA MARIA WATER DISTRICT**" (hereinafter called "the Works") and the Entity has accepted the Bid for **SEVEN HUNDRED FIFTY THOUSAND NINE HUNDRED NINE PESOS AND 46/100 (750,909.46)** by the Contractor for the execution and completion of such works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
2. The following documents shall be attached, deemed to form, and be read and construed as part of this Agreement, viz:
 - (a) the Bid Form and the Price Schedule submitted by the Bidder;
 - (b) the Work Schedule & S- Curve;
 - (c) the PERT/CPM;
 - (d) the General Conditions of Contract;
 - (e) the Special Conditions of Contract; and
 - (f) the Entity's Notification of Award;
3. In consideration of the payments to be made by the Entity to the Contractor as hereinafter mentioned, the Contractor hereby covenants with the Entity to provide the goods and services and to remedy defects therein in conformity in all respects with the provisions of the Contract.
4. The Entity hereby covenants to pay the Contractor in consideration of the provision of the goods and services and the remedying of defects wherein, the Contract Price or such other sum as may become payable under the provisions of this Contract at the time and in the manner prescribed by this Contract.

IN WITNESS whereof the parties thereto have caused this Agreement to be executed the day and year first before written.
