MARIA WATER DISTRICT with principal office address at No. 3 M. de Leon St., Poblacion, Santa Maria, Bulacan (hereinafter called the "Entity") and AVK PHILIPPINES, INC. with principal office address at No. 70 West Avenue, Brgy. West Triangle, Quezon City (hereinafter called the "Supplier").
