THIS AGREEMENT, made this 21st day of January, 2019 between SANTA. MARIA WATER DISTRICT with principal office address at No. 3 M. de Leon St., Poblacion, Santa Maria, Bulacan (hereinafter called the "Entity") and ALUMINATES METERING SUPPLY COMPANY, INC. with principal office address at 20C Malaya Street, Malanday, Marikina City (hereinafter called the "Supplier").

WHEREAS, the Entity is desirous that the Supplier execute the project, "SUPPLY AND DELIVERY OF CLASS "B" WATER METER REQUIREMENTS OF THE SMWD FOR CY 2019" (hereinafter called "the Works") and the Entity has accepted the Bid for <u>FOUR MILLION NINE HUNDRED EIGHTY THREE THOUSAND SEVEN HUNDRED SIXTY TWO PESOS AND 50 CENTAVOS (P 4.983,762.50)</u> by the Supplier for the execution and completion of such works and the remedying of any defects therein.

The Entity hereby covenants to pay the Supplier in consideration of the provision of the goods and services and the remedying of defects wherein, the Contract Price or such other sum as may become payable under the provisions of this Contract at the time and in the manner prescribed by this Contract.
