Accordingly, you are requested or your duly authorized representative (covered with such authority) to sign the Contract upon advise from the Santa Maria Water District.



CONTRACT AGREEMENT

No. CA-2019-01-001

THIS AGREEMENT, made this 21st day of January, 2019 between **SANTA. MARIA WATER DISTRICT** with principal office address at No. 3 M. de Leon St., Poblacion, Santa Maria, Bulacan (hereinafter called the "Entity") and **ALUMINATES METERING SUPPLY COMPANY, INC.** with principal office address at 20C Malaya Street, Malanday, Marikina City (hereinafter called the "Supplier").

WHEREAS, the Entity is desirous that the Supplier execute the project, "SUPPLY AND DELIVERY OF CLASS "B" WATER METER REQUIREMENTS OF THE SMWD FOR CY 2019" (hereinafter called "the Works") and the Entity has accepted the Bid for **FOUR MILLION NINE HUNDRED EIGHTY THREE THOUSAND SEVEN HUNDRED SIXTY TWO PESOS AND 50 CENTAVOS (P 4,983,762.50)** by the Supplier for the execution and completion of such works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
2. The following documents shall be attached, deemed to form, and be read and construed as part of this Agreement, viz:
 - (a) the Bid Form and the Price Schedule submitted by the Bidder;
 - (b) the Schedule of Requirements;
 - (c) the Technical Specifications;
 - (d) the General Conditions of Contract;
 - (e) the Special Conditions of Contract; and
 - (f) the Entity's Notification of Award;
3. In consideration of the payments to be made by the Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Entity to provide the goods and services and to remedy defects therein in conformity in all respects with the provisions of the Contract.
4. The Entity hereby covenants to pay the Supplier in consideration of the provision of the goods and services and the remedying of defects wherein, the Contract Price or such other sum as may become payable under the provisions of this Contract at the time and in the manner prescribed by this Contract.






