CONTRACT AGREEMENT

SUPPLY & DELIVERY OF UPVC PIPES AND ELBOWS FOR PIPE LAYING PROJECTS OF THE SMWD FOR THE YEAR 2019 No. CA2019-05-016

THIS AGREEMENT, made this 29th day of May 2019 between SANTA. MARIA WATER DISTRICT with principal office address at No. 3 M. de Leon St., Poblacion, Santa Maria, Bulacan (hereinafter called the "Entity") and ATLANTA INDUSTRIES, INC. with principal office address at 35TH Floor, Atlanta Centre Bldg., No. 31 Annapolis St., Greenhills, San Juan City (hereinafter called the "Supplier").



NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:


1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.

 - (e) the Special Conditions of Contract; and
 - (f) the Entity's Notification of Award;
3. In consideration of the payments to be made by the Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Entity to provide the goods and services and to remedy defects therein in conformity in all respects with the provisions of the Contract.
4. The Entity hereby covenants to pay the Supplier in consideration of the provision of the goods and services and the remedying of defects wherein, the Contract Price or such other sum as may become payable under the provisions of this Contract at the time and in the manner prescribed by this Contract.
