C. Surety bond callable upon demand issued by a surety or insurance company duly certified by the Insurance Commission as authorized to issue such security	P 341,237.25 (30% of the Contract Price)

Accordingly, you are requested or your duly authorized representative (covered with such authority) to sign the Contract upon advise from the Santa Maria Water District.

Within five (5) calendar days from signing of the Contract, an official Notice to Proceed will be issued and you are required to execute the contract with the Santa Maria Water District. Failure or refusal on your part to execute the said contract or to submit the said documents shall be considered just cause for the cancellation of the award.

CONTRACT AGREEMENT CA-2019-07-021

THIS AGREEMENT, made this 24th day of July, 2019 between SANTA. MARIA WATER DISTRICT with principal office address at No. 3 M. de Leon St., Poblacion, Santa Maria, Bulacan (hereinafter called the "Entity") and E.C. LAFORTEZA CONSTRUCTION with principal office address at Block 13 Lot 7, Commonwealth Avenue, Jordan Plains Subdivision, Phase 3, Novaliches, Quezon City (hereinafter called the "Contractor").

WHEREAS, the Entity is desirous that the Contractor execute the project, "**SUPPLY OF LABOR AND MATERIALS FOR THE CONSTRUCTION OF BRIDGE CROSSING FOR VARIOUS SMWD PROJECTS**" (hereinafter called "the Works") and the Entity has accepted the Bid for **ONE MILLION ONE HUNDRED THIRTY SEVEN THOUSAND FOUR HUNDRED FIFTY SEVEN PESOS AND FIFTY CENTAVOS (1,137,457.50)** by the Contractor for the execution and completion of such works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:


1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
2. The following documents shall be attached, deemed to form, and be read and construed as part of this Agreement, viz:

 - (b) the Construction CPM and S-Curve;
 - (c) the Construction Schedule and S-Curve;
 - (d) the General Conditions of Contract;
 - (e) the Special Conditions of Contract;
 - (f) the Bid Data Sheet;
 - (g) the Entity's Notification of Award; and
 - (h) the Supplemental/Bid Bulletin 2019-006
3. In consideration of the payments to be made by the Entity to the Contractor as hereinafter mentioned, the Contractor hereby covenants with the Entity to provide the goods and services and to remedy defects therein in conformity in all respects with the provisions of the Contract.
4. The Entity hereby covenants to pay the Contractor in consideration of the provision of the goods and services and the remedying of defects wherein, the Contract Price or such other sum as may become payable under the provisions of this Contract at the time and in the manner prescribed by this Contract.
