## CONTRACT AGREEMENT CA 2019-10-024

### SUPPLY & DELIVERY OF UPVC PIPES AND ELBOWS FOR (A) REVISION OF PIPE LAYING PROJECT AT SITIO LAOT AND SITIO LIBIS, BRGY. BUENAVISTA (B) REPLACEMENT OF OLD PIPELINES AT BRGY. GUYONG AND (C) FOR REPAIR AND MAINTENANCE PURPOSES OF THE SMWD

THIS AGREEMENT, made this 16th day of October 2019 between SANTA. MARIA WATER DISTRICT with principal office address at No. 3 M. de Leon St., Poblacion, Santa Maria, Bulacan (hereinafter called the "Entity") and ATLANTA INDUSTRIES, INC. with principal office address at 35<sup>TH</sup> Floor, Atlanta Centre Bldg., No. 31 Annapolis St., Greenhills, San Juan City (hereinafter called the "Supplier").

WHEREAS, the Entity is desirous that the Supplier execute the project, "**SUPPLY AND DELIVERY OF UPVC PIPES AND ELBOWS FOR (A) REVISION OF PIPE LAYING PROJECT AT SITIO LAOT AND SITIO LIBIS, BRGY. BUENAVISTA (B) REPLACEMENT OF OLD PIPELINES AT BRGY. GUYONG AND (C) FOR REPAIR AND MAINTENANCE PURPOSES OF THE SMWD**" (hereinafter called "the Works") and the Entity has accepted the Bid for **TWO MILLION ONE HUNDRED NINETY SIX THOUSAND TWO HUNDRED TWENTY EIGHT PESOS (P 2,196,228.00)** by the Supplier for the execution and completion of such works and the remedying of any defects therein.

#### NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
2. The following documents shall be attached, deemed to form, and be read and construed as part of this Agreement, viz:
  - (a) the Bid Form and the Bill of Quantities submitted by the Bidder;
  - (b) the Schedule of Requirements;
  - (c) the Technical Specifications;
  - (d) the General Conditions of Contract;
  - (e) the Special Conditions of Contract; and
  - (f) the Entity's Notification of Award;
3. In consideration of the payments to be made by the Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Entity to provide the goods and services and to remedy defects therein in conformity in all respects with the provisions of the Contract.
4. The Entity hereby covenants to pay the Supplier in consideration of the provision of the goods and services and the remedying of defects wherein, the Contract Price or such other sum as may become payable under the provisions of this Contract at the time and in the manner prescribed by this Contract.

IN WITNESS whereof the parties thereto have caused this Agreement to be executed the day and year first before written.


