

Resolution No. BCR 2019-047 Date: December 2, 2019

Project: Well Drilling of Two (2) 200 mm Diameter Pilot Hole with Supply and Delivery of Screens and Casings

BAC Resolution Declaring SCRB and Recommending Award of the Project to DRILL MECHANICS, INC.

WHEREAS, the Santa Maria Water District through the Bids and Awards Committee (BAC), posted Invitation to Bid for the above stated project in the SMWD website, posted the same in Philgeps website and in conspicuous place in the premises of Santa Maria Water District's office for seven (7) days, from October 25 TO November 1, 2019. And to enhance the transparency of the process, invitations were also sent to three (3) observers as set forth in the IRR of RA 9184;

WHEREAS, in response to the said invitation, only one (1) bidder submitted bidding documents. The documents were downloaded from the website of Philgeps and the prescribed fee for the documents was paid to the SMWD cashier prior to submission of the bidding documents. The lone bidder for the project was DRILL MECHANICS, INC. The bidding documents were submitted by Mr. Victorino P. Literal in one (1) Mother Envelope properly sealed and marked before 10:00 AM of the scheduled submission of bids on November 18, 2019;

WHEREAS, the bidder, DRILL MECHANICS, INC., was declared by the SMWD BAC as eligible bidder, the bidding documents of the eligible bidder, was opened and passed the preliminary examination of bids;
