

Resolution No. BCR 2019-050 Date: December 6, 2019

Project: Supply and Delivery of One (1) Unit Brand New Service Vehicle – Passenger Van of the SMWD for the Year 2019

BAC Resolution Declaring SCRB and Recommending Award of the Project to TOYOTA BALINTAWAK, INC.

WHEREAS, the Santa Maria Water District through the Bids and Awards Committee (BAC), posted Invitation to Bid for the above stated project in the SMWD website, posted the same in Philgeps website and in conspicuous place in the premises of Santa Maria Water District's office for seven (7) days, from October 21 to 28, 2019. And to enhance the transparency of the process, invitations were also sent to three (3) observers as set forth in the IRR of RA 9184;

WHEREAS, in response to the said invitation, only one (1) bidder submitted bidding documents. He submitted bidding documents in one (1) Mother Envelope properly sealed and marked before 10:00 AM of the scheduled submission of bids on November 11, 2019;

WHEREAS, the bidder, TOYOTA BALINTAWAK, INC., was declared by the SMWD BAC as eligible bidder, the bidding documents of the eligible bidder, was opened and passed the preliminary examination of bids;
