



CONTRACT AGREEMENT

THIS AGREEMENT, made this 10th day of December, 2019 between SANTA. MARIA WATER DISTRICT with principal office address at No. 3 M. de Leon St., Poblacion, Santa Maria, Bulacan (hereinafter called the "Entity") and DRILL MECHANICS, INC. with principal office address at 3031 Mahogany Street, United Parañaque Subdivision II, Parañaque City, Metro Manila (hereinafter called the "Contractor").

WHEREAS, the Entity is desirous that the Contractor execute the project, "**WELL DRILLING OF TWO (2) 200MM DIAMETER PILOT HOLE WITH SUPPLY AND DELIVERY OF SCREENS AND CASINGS**" (hereinafter called "the Works") and the Entity has accepted the Bid for **SEVEN MILLION THREE HUNDRED EIGHTY THOUSAND FOUR HUNDRED PESOS (7,380,400.00)** by the Contractor for the execution and completion of such works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
2. The following documents shall be attached, deemed to form, and be read and construed as part of this Agreement, viz:
  - (a) the Bid Form and the Price Schedule submitted by the Bidder;
  - (b) the Construction CPM and S-Curve;
  - (c) the Construction Schedule and S-Curve;
  - (d) PERT CPM
  - (e) Construction Safety and Health Program
  - (f) Manpower and Equipment Utilization Schedule
  - (g) the General Conditions of Contract;
  - (h) the Special Conditions of Contract;
  - (i) Bid Data Sheet;
  - (j) the Entity's Notification of Award and the Bidder's conforme thereto;
  - (k) Supplemental/Bid Bulletin
  - (l) Eligibility Requirements, documents and/or statements
  - (m) Performance Security
3. In consideration of the payments to be made by the Entity to the Contractor as hereinafter mentioned, the Contractor hereby covenants with the Entity to provide the goods and services and to remedy defects therein in conformity in all respects with the provisions of the Contract.
4. The Entity hereby covenants to pay the Contractor in consideration of the provision of the goods and services and the remedying of defects wherein, the Contract Price or such other sum as may become payable under the provisions of this Contract at the time and in the manner prescribed by this Contract.
