



CONTRACT AGREEMENT

THIS AGREEMENT, made this 27th day of December 2019 between SANTA MARIA WATER DISTRICT with principal office address at No.3 M.de Leon St., Poblacion, Santa Maria, Bulacan (hereinafter called the "Entity") and TOYOTA BALINTAWAK, INC. with principal office address at EDSA cor. V. Ang & Gen. Evangelista Sts., Caloocan City (hereinafter called the "Supplier").

WHEREAS, the Entity is desirous that the Supplier execute the project, "SUPPLY AND DELIVERY OF ONE (1) UNIT BRAND NEW SERVICE VEHICLE – PASSENGER VAN OF THE SMWD FOR THE YEAR 2019" (hereinafter called "the Works") and the Entity has accepted the Bid for **TWO MILLION ONE HUNDRED FORTY SIX THOUSAND PESOS (P 2,146,000.00)** by the Supplier for the execution and completion of such works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
2. The following documents shall be attached, deemed to form, and be read and construed as part of this Agreement, viz:
 - (a) the Bid Form and the Price Schedule submitted by the Bidder;
 - (b) the Schedule of Requirements;
 - (c) the Technical Specifications;
 - (d) the General Conditions of Contract;
 - (e) the Special Conditions of Contract; and
 - (f) the Entity's Notification of Award;
 - (g) the Eligibility Documents
 - (h) the Supplemental/BID Bulletin No. 2019-010
3. In consideration of the payments to be made by the Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Entity to provide the One (1) brand new service vehicle, passenger Van with the specifications as mentioned in the bidding documents and to remedy defects therein in conformity in all respects with the provisions of the Contract.
4. The Entity hereby covenants to pay the Supplier in consideration of the provision of the goods and services and the remedying of defects wherein, the Contract Price or such other sum as may become payable under the provisions of this Contract at the time and in the manner prescribed by this Contract.
