WHEREAS, the Santa Maria Water District BAC secretariat posted In PhilGeps and SMWD's website an invitation to Bid for the above stated project for the period November 27 to December 4, 2019. The same invitation was sent to three (3) observers such as Commission on Audit (COA), Soroptomist International of Santa Maria, and Bulacan Chamber of Commerce and Industry. The invitation was also posted in conspicuous premise of the Santa Maria Water District's office on the same period;

WHEREAS, in response to the said invitation, only one manufacturer of uPVC pipes and elbows bought bidding documents and submitted the same on December 17, 2019 at 9:09 in the morning prior to the deadline of bid opening which is 10:00 A.M that day;

WHEREAS, prior to the bidding of this project, Atlanta Industries, Inc. was already declared eligible bidder last May 2019 so the BAC had just checked updated documents such as the on-going and single largest completed projects, the NFCC and the Bid Security posted. All the required documents were present and intact so the BAC moved in the opening of the Financial documents of the bidder where it has passed the preliminary examination of bids;



### SUPPLY & DELIVERY OF UPVC PIPES FOR PIPE LAYING OF THE PHILHYDRO BULK SUPPLY IMPROVEMENT PROJECT

THIS AGREEMENT, made this 9th day of January 2020 between SANTA. MARIA WATER DISTRICT with principal office address at No. 3 M. de Leon St., Poblacion, Santa Maria, Bulacan (hereinafter called the "Entity") and ATLANTA INDUSTRIES, INC. with principal office address at 35<sup>TH</sup> Floor, Atlanta Centre Bldg., No. 31 Annapolis St., Greenhills, San Juan City (hereinafter called the "Supplier").

WHEREAS, the Entity is desirous that the Supplier execute the project, "**SUPPLY AND DELIVERY OF UPVC PIPES FOR PIPE LAYING OF THE PHILHYDRO BULK SUPPLY IMPROVEMENT PROJECT**" (hereinafter called "the Works") and the Entity has accepted the Bid for **FOUR MILLION ONE HUNDRED SIXTY EIGHT THOUSAND NINE HUNDRED EIGHT PESOS (P 4,168,908.00)** by the Supplier for the execution and completion of such works and the remedying of any defects therein.

#### NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
2. The following documents shall be attached, deemed to form, and be read and construed as part of this Agreement, viz:
  - (a) the Bid Form and the Bill of Quantities submitted by the Bidder;
  - (b) the Schedule of Requirements;
  - (c) the Technical Specifications;
  - (d) the General Conditions of Contract;
  - (e) the Special Conditions of Contract;
  - (f) the Eligibility Documents listed in BDS;
  - (g) the Entity's Notification of Award;
3. In consideration of the payments to be made by the Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Entity to provide the uPVC pipes identified in the bidding documents and to remedy defects therein in conformity in all respects with the provisions of the Contract.
4. The Entity hereby covenants to pay the Supplier in consideration of the provision of the goods and services and the remedying of defects wherein, the Contract Price or such other sum as may become payable under the provisions of this Contract at the time and in the manner prescribed by this Contract.
