BAC Resolution Declaring SCRB and Recommending Award of the Project to E.C. LAFORTEZA CONSTRUCTION

WHEREAS, the Santa Maria Water District through the Bids and Awards Committee (BAC), posted Invitation to Bid for the above stated project in the SMWD website, posted the same in Philgeps website and in conspicuous place in the premises of Santa Maria Water District's office for seven (7) days, from October 25 TO November 1, 2019. And to enhance the transparency of the process, invitations were also sent to three (3) observers as set forth in the IRR of RA 9184;

WHEREAS, in response to the said invitation, only one (1) bidder submitted bidding documents. The documents were downloaded from the website of Philgeps and the prescribed fee for the documents was paid to the SMWD cashier prior to submission of the bidding documents. The lone bidder for the project was E.C. LAFORTEZA CONSTRUCTION. The bidding documents were submitted by Engr. Edgardo C. Laforteza in one (1) Mother Envelope properly sealed and marked on 9:20 AM of the scheduled submission of bids on November 18, 2019;

WHEREAS, the bidder, E.C. LAFORTEZA CONSTRUCTION., was declared by the SMWD BAC as eligible bidder, the bidding documents of the eligible bidder, was opened and passed the preliminary examination of bids;



- b) To recommend for approval by the General Manager of the Santa Maria Water District the foregoing findings.





CONTRACT AGREEMENT CA-2019-12-029

THIS AGREEMENT, made this 10th day of December, 2019 between SANTA. MARIA WATER DISTRICT with principal office address at No. 3 M. de Leon St., Poblacion, Santa Maria, Bulacan (hereinafter called the "Entity") and E.C. LAFORTEZA CONSTRUCTION with principal office address at Block 13 Lot 7, Commonwealth Avenue, Jordan Plains Subdivision, Phase 3, Novaliches, Quezon City (hereinafter called the "Contractor").

WHEREAS, the Entity is desirous that the Contractor execute the project, "**SUPPLY OF LABOR AND MATERIALS FOR THE CONSTRUCTION OF PUMP HOUSE AND SITE DEVELOPMENT AT SACRED HEART AND CELESTE PUMP STATION**" (hereinafter called "the Works") and the Entity has accepted the Bid for **NINE HUNDRED SIXTY ONE THOUSAND NINE HUNDRED SIXTY PESOS AND SEVENTY SIX CENTAVOS (P 961,960.76)** by the Contractor for the execution and completion of such works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
2. The following documents shall be attached, deemed to form, and be read and construed as part of this Agreement, viz:
 - (a) the Bid Form and the Price Schedule submitted by the Bidder;
 - (b) the Narrative Description of Construction Method;
 - (c) the PERT/CPM;
 - (d) Construction Schedule and S-Curve;
 - (e) Manpower and Equipment Schedule;
 - (f) the General Conditions of Contract;
 - (g) the Special Conditions of Contract;
 - (h) the Bid Data Sheet;
 - (i) the Entity's Notification of Award; and
 - (j) the Supplemental/Bid Bulletin 2019-012
3. In consideration of the payments to be made by the Entity to the Contractor as hereinafter mentioned, the Contractor hereby covenants with the Entity to provide the goods and services and to remedy defects therein in conformity in all respects with the provisions of the Contract.
4. The Entity hereby covenants to pay the Contractor in consideration of the provision of the goods and services and the remedying of defects wherein, the Contract Price or such other sum as may become payable under the provisions of this Contract at the time and in the manner prescribed by this Contract.

IN WITNESS whereof the parties thereto have caused this Agreement to be executed the day and year first before written.




