### BAC Resolution Declaring SCRB and Recommending Approval

WHEREAS, the Santa Maria Water District BAC Secretariat posted in PhilGeps and SMWD's website an invitation to Apply for Eligibility and to Bid for the above-stated project for the period of February 3 to 10, 2020. The same invitation was posted at conspicuous premises of the Santa Maria Water District's office on the same period;

WHEREAS, in response to the said invitation, only one (1) bidder downloaded bidding documents from the PhilGeps website and that was Chemical Research Products Industrial Sales, Inc. and purchased bidding documents and submitted the same on February 24, 2020, at 9:05 AM;

WHEREAS, the SMWD BAC upon thorough evaluation and checking of all the eligibility and technical documents declared Chemical Research Products Industrial Sales, Inc., as eligible bidder, and the Financial Envelop was opened and passed the preliminary examination of bids;
