Supply and Delivery of HDPE Tubing and Plastic Fittings Requirement of the SMWD for CY 2020

BAC Resolution Declaring Lowest Calculated Responsive BID (LCRB) and Recommending Award for the Above Stated Project

WHEREAS, the Santa Maria Water District BAC secretariat posted In PhilGEPS and SMWD's website an invitation to Bid for the above stated projects for the period June 23 to 29, 2020. The same invitations were sent to three (3) observers and were also posted at conspicuous premise of the Santa Maria Water District's office on the same period;

WHEREAS, in response to the said invitation, three (3) prospective bidders purchased bidding documents from the SMWD's cashier prior to Bid Submission on July 13, 2020. The following are the names of the bidders/representative and the date and time of their submission:

WHEREAS, the eligibility documents of the bidders, were opened one by one and passed the preliminary examination of bids. The SMWD BAC after thoroughly checking and verifying all the documents declared **Moldex Products, Inc.** ineligible to bid due to non-compliant with some instructions, non-submission of Audited Financial Statement for the year 2019, and misrepresentation in the computation of the NFCC. The financial envelope of this bidder was not opened, remained intact and returned to the representative of Moldex Products, Inc., Mr. Rico de Castro;

WHEREAS, the bid amount as read of HDR Plastic Manufacturing Corporation was declared as the Lowest Bid as Read and that of Hydro Phil. Asia Inc. was the Second Lowest Bid as Read;

WHEREAS, Bid Evaluation was made on July 14, 2020 on the bid submitted by the bidders. There's no discrepancy on the bid as read and calculated of HDR PRODUCTS, INC. while a little discrepancy was found on the bid as read and calculated of HYDRO PHIL ASIA, INC.;

WHEREAS, post-qualification was made on July 15 to 22, 2020 to all the eligibility, technical and financial documents submitted by both bidders wherein careful examination, validation and verification were done by the BAC. The HDPE tubing and plastic fittings offered by both bidders were inspected and it was found that the uPVC Coupling $\frac{1}{2}$, $\frac{3}{4}$ and 1" offered by **HDR PLASTIC PRODUCTS, INC.** were found to be non-compliant with the technical specifications required by the SMWD so this bidder was declared as **non-responsive**;

WHEREAS, **HYDRO PHIL ASIA, INC.** was found complying in all aspects and it was declared to have the capacity legally, technically and financially to implement the project. The SMWD BAC hence declared this bidder as **responsive**;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby **RESOLVED** as it is hereby **RESOLVED**:

1. To declare **HYDRO PHIL ASIA, INC.** with office address at No. 393 G.P Purok 3, Brgy. Lumang Bayan, Plaridel, Bulacan as the Bidder who is the Lowest Calculated Responsive Bid for the project, **Supply & Delivery of HDPE Tubing and Plastic Fittings Requirement of the SMWD for CY 2020.** And to recommend the contract award in the amount of **Two Million Ten Thousand Forty Four Pesos and 06/100 (P 2,010,044.06).**
2. To recommend for approval by the General Manager of the Santa Maria Water District the foregoing findings.
