## BAC RESOLUTION RECOMMENDING AWARD FOR THE PROJECT, PROCUREMENT OF CALCIUM HYPOCHLORITE AND CHLORINE DIOXIDE LIQUID FOR SMWD'S REQUIREMENTS FOR CY 2021

### BAC RESOLUTION NO. 2021-009

WHEREAS, the Santa Maria Water District BAC initiated bidding for the above stated project. The BAC secretariat has published In PhilGeps and SMWD's website an invitation to Bid for the period, December 11 to 18, 2020. The same invitation was sent to three (3) observers and was also posted at conspicuous premise of the Santa Maria Water District's office on the same period;

WHEREAS, in response to the said invitation, only one supplier of chemical responded to the ITB or Invitation to Bid. The company was **Chemical Research Products Industrial Sales Inc. or CHEMRES**, a company well known and a recognized supplier of high quality Calcium Hypochlorite. It purchased bidding documents and submitted the same on December 29, 2020 at 10:45 AM, which was six (6) days prior to bid submission and opening on January 4, 2021;

WHEREAS, no other bidder submitted bidding documents till the scheduled bid opening for the project, the BAC pushed thru with the bid opening at exactly 1:00 PM, January 4, 2021. The representative of the bidder were present namely, Ms. Marissa Directo and Joyce Royales;

WHEREAS, the SMWD BAC upon thorough evaluation and examination of all the eligibility and technical documents declared Chemical Research Products Industrial Sales, Inc. as eligible bidder. The bidding documents of the eligible bidder, was opened and passed the preliminary examination of bids;

WHEREAS, Bid Evaluation was made on January 5, 2021 on the bid submitted by the bidder and found no discrepancy on the detailed bids against the total bid amount:

WHEREAS, post-qualification was conducted on January 7, 2021 by Engr. Mac Daniel Alejandro., BAC Member-End User and BAC Secretariat, Charito S. Fernando. The sample of calcium hypochlorite was brought at PIPAC Laboratory for testing, unfortunately the result was unfavorable, the chlorine is only sixty four percent (64%), the chlorine content required is seventy percent (70%);

WHEREAS, on January 29, 2021, another chlorine sample was brought again at PIPAC Laboratory for testing, the sample came from the latest batch of chlorine available in the bidder's warehouse.


