BAC Resolution Recommending Award of contract, "SUPPLY OF SECURITY SERVICES IN VARIOUS SMWD OFFICES FOR A PERIOD OF ONE (1) YEAR" to OMNICHRON SECURITY AGENCY, INC.

Reference No. PB2021-SMWD-S002

WHEREAS, by virtue of the published invitation to apply for eligibility and to bid in the SMWD website and in the Philippine Government Electronic Procurement System (PhilGEPS), Omnichron Security Agency, Inc. participated in the Public Bidding for the above stated project with an approved budget for the contract of Two Million Seven Hundred Thirteen Thousand Two Hundred Pesos (Php 2,713,200.00);

WHEREAS, the BAC issued Supplemental/Bid Bulletin No. SBB2021-001 instructing interested bidders to submit only two (2) copies of the Bidding Documents, Original Copy and Copy 1 instead of three (3) copies as stated in the published Public Bidding Documents;

WHEREAS, on January 6, 2021 at 10:00 AM, a Pre-bid Conference was held to discuss the different aspects of the bidding documents, eligibility, technical and Financial components The pre-bid was attended by two (2) prospective bidders, Omnichron Security Agency, Inc. and Yourguard Security & Investigation Agency, Inc.;

WHEREAS, only one prospective bidder, the Omnichron Security Agency, Inc., purchased the bidding documents in the amount of five thousand pesos (PhP5,000.00);

WHEREAS, on January 18, 2021 at 9:45AM, Mr. Leo Abrera of Omnichron Security Agency, Inc., submitted bidding documents sealed in a Mother envelope containing Eligibility, Technical and Financial Bid. The bid opening started at 1:00PM as scheduled, no representative of the bidder witnessed the bid opening;

WHEREAS, the BAC opened the financial bid proposal of Omnichron Security Agency, Inc. having passed the eligibility and technical requirements, thus the bid is as follows:

2 Guards 12 hours 6 days contract AM at P24,928.28 x 12 months.....	PhP598,278.72
6 Guards 12 hours 7 days contract AM/PM @ P29,373.91 x 12 mos.....	2,114,921.28
TOTAL BID.....	PhP2,713,200.00

WHEREAS, on January 22, 2021 Post Qualification evaluation was made to the bidder, Omnichron Security Agency, Inc., the BAC sought to verify, validate and examine all the documents submitted by the bidder during the submission and opening of Bids. Omnichron Security Agency, Inc., was able to submit the renewed PhilGEPS Registration (Platinum Membership) on January 26, 2021 and its updated Tax Clearance which was issued by the Bureau of Internal Revenue Region 5 on January 22, 2021:

WHEREAS, Omnichron Security Agency, Inc., having passed the Post Qualification Evaluation, was declared to be the Single Calculated and Responsive Bidder.

WHEREFORE, the BIDS AND AWARDS COMMITTEE RESOLVES, as it hereby RESOLVED, to recommend to the Head of the Procuring Entity, for his approval, the award of contract, SUPPLY OF SECURITY SERVICES IN VARIOUS SMWD OFFICES FOR A PRIOD OF ONE (1) YEAR, to OMNICHRON SECURITY AGENCY, INC. of A and S Building, J.P Rizal St., Poblacion, Santa Maria, Bulacan, with the contract price of TWO MILLION SEVEN HUNDRED THIRTEEN THOUSAND TWO HUNDRED PESOS (PhP2,713,200.00.


