THIS AGREEMENT, made this 19th day of February 2021 between **SANTA MARIA WATER DISTRICT** and **OMNICHRON SECURITY AGENCY, INC.**

KNOWN ALL MEN BY THESE PRESENTS:

SANTA MARIA WATER DISTRICT, a Government Owned and Controlled Corporation (GOCC) duly organized and existing under and by virtue of Presidential Decree No. 198, as amended, with principal office address at No. 3 M. de Leon St., Poblacion, Santa Maria, Bulacan, represented by its General Manager, **ENGR. CARLOS N. SANTOS, JR.**, duly authorized for this purpose, hereinafter called the **ENTITY**.

And-

OMNICHRON SECURITY, INC., a duly organized and existing entity under and by virtue of the laws of the Republic of the Philippines, with principal office address at A & S Building, J.P. Rizal Street, Poblacion, Santa Maria, Bulacan, represented by its President, **JAMES A. GO** hereinafter called the **CONTRACTOR**.

WITNESSETH:

WHEREAS, in response to the ENTITY's Invitation to Bid, the **PROVIDER** submitted its bid to the Procuring Entity to provide **SUPPLY OF SECURITY SERVICES IN VARIOUS SMWD OFFICES FOR A PERIOD OF ONE (1) YEAR** for **SANTA MARIA WATER DISTRICT**;

WHEREAS, the bid of the **PROVIDER** was the **Single Calculated and Responsive Bid**;

WHEREAS, the ENTITY has awarded the Contract to the **CONTRACTOR** at the price stipulated in its winning BID of **TWO MILLION SEVEN HUNDRED THIRTEEN THOUSAND TWO HUNDRED PESOS (PhP2,713,200.00)** inclusive of taxes;

WHEREAS, the Entity is desirous that the Contractor execute the project, "**SUPPLY OF SECURITY SERVICES IN VARIOUS SMWD OFFICES FOR A PERIOD OF ONE (1) YEAR**" (hereinafter called "the Services") and the Entity has accepted the Bid for **TWO MILLION SEVEN HUNDRED THIRTEEN THOUSAND TWO HUNDRED PESOS (PhP2,713,200.00)** by the Provider for the supply of services in accordance with the Terms of Reference

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
2. The following documents shall be attached, deemed to form, and be read and construed as part of this Agreement, viz:
 - (a) the Bid Form;
 - (b) the Terms of Reference;

- (c) the General Conditions of Contract;
 - (d) the Special Conditions of Contract; and
 - (e) the Entity's Notification of Award;
3. In consideration of the payments to be made by the Entity to the Contractor as hereinafter mentioned, the Contractor hereby covenants with the Entity to provide the services and to remedy defects therein in conformity in all respects with the provisions of the Contract.
4. The Entity hereby covenants to pay the Contractor in consideration of the provision of the services and the remedying of defects wherein, the Contract Price or such other sum as may become payable under the provisions of this Contract at the time and in the manner prescribed by this Contract.
5. This contract shall be re-enforceable retroactively from January 1, 2021 and will end on December 31, 2021. The contract may likewise be extended by the SMWD for a maximum of six (6) months, subject to the result of the performance evaluation of the Contractor, exigency of service, availability of funds and upon mutual agreement of the parties.
