

## SUPPLEMENTAL/BID BULLETIN SBB2021-005

## For the Project:

## DESIGN AND CONSTRUCTION OF PUMPHOUSE WITH BOOSTER PUMP AND GLASS-FUSED TO STEEL BOLTED GOUND RESERVOIRS Reference No. WDDSP-STM-OCB-CWO5b

In accordance with Section 22.5.2 of IRR of RA No. 9184, the SMWD-BAC is issuing this Supplemental/Bid Bulletin to make an addendum and clarifications to the bidding documents of the above stated project.

## **CLARIFICATIONS:**

1. The prospective bidders clarified if the documents required to be submitted per Section 6 Employer's Requirement should be authenticated by Philippine Consul or the Office of the local Chamber of Commerce

**BAC clarified,** "AUTHENTICATION REQUIREMENT FROM THE PHILIPPINE CONSUL OR THE OFFICE OF LOCAL CHAMBER OF COMMERCE FOR THE DOCUMENTS TO BE SUBMITTED PER SECTION 6 – EMPLOYER'S REQUIREMENT IS NO LONGER REQUIRED".

2. The prospective bidders clarified if there is a specified duration for the plants and mandatory spare parts, and if ever there is how many years will be projected for that.

BAC clarified, Special Condition of the Contract (SCC) 7.3 Section 8 states that:

The Contractor agrees to supply spare parts for a period of years: five (5) years

3. The prospective bidders asked, "What is the basis over the mandatory spare parts if there is also a projected years?"

The BAC clarified with reference to GCC/SCC 7.3, Section 8:

The Contractor shall carry sufficient inventories to ensure an ex-stock supply of consumable spares for the Plant. Other spare parts and components shall be supplied as promptly as possible, but at the most within 6 months of placing the order and opening the letter of credit. In addition, in the event of termination of the production of spare parts, advance notification will be made to the Employer of the pending termination, with sufficient time to permit the Employer to procure the needed requirement. Following such termination, the Contractor will furnish to the extent possible and at no cost to the Employer the blueprints, drawings and specifications of the spare parts, if requested.
