THIS AGREEMENT, made this 26th day of March 2021 between **SANTA MARIA WATER DISTRICT** and **GLOBAL SUPPLY SOLUTIONS CORPORATION**.

KNOWN ALL MEN BY THESE PRESENTS:

SANTA MARIA WATER DISTRICT, a Government Owned and Controlled Corporation (GOCC) duly organized and existing under and by virtue of Presidential Decree No. 198, as amended, with principal office address at No. 3 M. de Leon St., Poblacion, Santa Maria, Bulacan, represented by its General Manager, **ENGR. CARLOS N. SANTOS, JR.**, duly authorized for this purpose, hereinafter called the **ENTITY**.

And-

GLOBAL SUPPLY SOLUTIONS CORPORATION, a duly organized and existing entity under and by virtue of the laws of the Republic of the Philippines, with principal office address at Unit 315 Armons Building, 142 Anonas Street, cor. Kamias, Quezon City, represented by its Authorized Managing Officer/C.S.O, **REYNATO A. ELORTA**, hereinafter called the **CONTRACTOR**.

WITNESSETH:

WHEREAS, in response to the ENTITY's Invitation to Bid, the **CONTRACTOR** submitted its bid to the Procuring Entity to implement the project, **PROCUREMENT OF TREATED BULK WATER SUPPLY FOR SANTA MARIA WATER DISTRICT**;

WHEREAS, the bid of the **CONTRACTOR** was the **Single Calculated and Responsive Bid**;

WHEREAS, the ENTITY has awarded the Contract to the **CONTRACTOR** at the price stipulated in its winning BID of **TWELVE PESOS AND NINETY FIVE CENTAVOS (PhP12.95) per cubic meter of treated water supply** inclusive of taxes:

WHEREAS, the Entity is desirous that the Contractor execute the project, "**PROCUREMENT OF TREATED BULK WATER SUPPLY FOR SANTA MARIA WATER DISTRICT**" (hereinafter called "the Works") and the Entity has accepted the Bid for **TWELVE PESOS AND NINETY FIVE CENTAVOS (PhP12.95) per cubic meter of treated water supply** by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
2. The following documents shall be attached, deemed to form, and be read and construed as part of this Agreement, viz:
 - (a) the Contractor's Bid Form;
 - (b) the Technical Specifications including Terms of Reference;

- (c) the General Conditions of Contract;
- (d) the Special Conditions of Contract;
- (e) the Performance Security;
- (f) the Entity's Notification of Award;
- (g) Other contract documents relevant to the project.

3. In consideration of the payments to be made by the Entity to the Contractor as hereinafter mentioned, the Contractor hereby covenants with the Entity to provide the goods and services and remedy any defects therein in conformity with the provisions of this Contract in all respects.
4. The Entity hereby covenants to pay the Contractor in consideration of the execution and completion of the Works and the remedying of defects wherein, the Contract Price or such other sum as may become payable under the provisions of this Contract at the times and in the manner prescribed by this Contract.
