- The Government of the Republic of the Philippines has received financing from the Asian Development Bank (ADB) toward the cost of the Water District Development Sector Project. Part of this financing will be used for payments under the contract named above. Bidding is open to Bidders from eligible source countries of the ADB.
- 2 The Santa Maria Water District (the Employer) through the Local Water Utilities Administration (the "Procurement Agent"), invites sealed bids from eligible Bidders for the design and construction of pump house with booster pump and glass-fused-to-steel bolted ground reservoirs ("the Facilities").
- 3 Open Competitive Bidding National will be conducted in accordance with ADB's <u>Single-Stage</u>: <u>Two-Envelope</u> procedure and is open to all Bidders from eligible source countries as described in the Bidding Document.
- 4 Only eligible Bidders with the following key qualifications should participate in this bidding:

Historical Contract Non-Performance

Non-performance of a contract did not occur as a result of contractor default since 1 January 2015.

Financial Situation

- Historical Financial Performance: As a minimum, the Bidder's net worth for the last year calculated as
 the difference between total assets and total liabilities should be positive.
- Average Annual Turnover: Minimum average annual turnover of PhP76 Million calculated as total certified payments received for contracts in progress or completed, within the last three (3) years.
- Financial Resources: The Bidder must demonstrate that its financial resources, less its financial obligations for its current contract commitments meet or exceed the total requirement for the Subject Contract of PhP10 Million

Construction Experience

- Contracts of Similar Size and Nature: Participation as a contractor, JV partner, or subcontractor, in at
 least two contracts that have been successfully or substantially completed within the last ten (10) years
 (or Projects completed after 1 January 2010 will only be considered) and that are similar to the proposed
 contract, where the value of the Bidder's participation under each contract exceeds PhP30 Million. The
 similarity of the Bidder's participation shall be based on components given in the Employer's
 Requirements.
- Experience in Key Activities: a minimum experience in the last ten (10) years for the following:
 - Detailed Engineering Design of pump house with booster pump and glass-fused-to-steel bolted ground reservoir with minimum capacity of 1000cum including related appurtenances;
 - Supply and installation of glass-fused-to-steel bolted ground reservoir with a minimum capacity

of 1000 cum including related appurtenances; and

Supply and installation of booster pump

 - Write to the address above requesting for the Bidding Documents for the Design and Construction of Pump House with Booster Pump and Glass-Fused-to-Steel Bolted Ground Level Reservoirs
 - Pay a nonrefundable fee of PhP25,000.00 by cash, cashier's check or manager's check.

Request for Bidding Document will be entertained during office hours (08:00 - 16:00 hours) from the date of posting but not later than the submission of bids.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (www.philgeps.gov.ph) provided that Bidders shall pay the applicable fee for the Bidding Document not later than the submission of its bids.

- 7. The Employer will hold a Pre-Bid Conference on 10 March 2021 at 1:00 P.M (Manila Time) at the SMWD Office at the address given above, which shall be open to prospective Bidders. Pre-bid Conference may be conducted in person, face-to-face through videoconferencing, webcasting, or similar technology, or a combination thereof.

Bid Package number should be marked on the top left corner of the original and duplicate envelopes.


