

BAC RESOLUTION NO. 2021-024

BAC RESOLUTION RECOMMENDING AWARD FOR THE PROJECT: CIVIL WORKS FOR PIPELAYING AND RELATED WORKS Reference No. WDDSP-STM-OCB-CWO5a

- Whereas, failure of bidding has been declared on December 2, 2020 per BAC Resolution no. 2020-043 for the first bidding of the project, Civil Works for Pipelaying and Related Works. The bidder, J.K. Builders was post-disqualified because of the deviations made in the Bill of Quantities;
- WHEREAS, the Santa Maria Water District Bids and Awards Committee (SMWD-BAC) had initiated rebidding for the project. The Invitation to Bid (ITB) has been published in the website of PhilGEPS and also in the website of Procuring Entity, the SMWD, from January 14 to February 15, 2021. A Pre-bid Conference was held on February 3, 2021 at 1:00 PM;
- WHEREAS, on the scheduled submission of bids, two prospective bidders submitted bidding documents on time. Mr. Sergio Reguyal, representative of C.T. LEONCIO CONSTRUCTION & TRADING/SSR CONSTRUCTION (JOINT VENTURE), submitted bidding documents on February 15, 2021 9:33 AM while Mr. Thomas Carter III, representative of ICP-FNET ENGINEERING, submitted the bidding documents on the same day at 10:40 PM. The scheduled submission is February 15, 2021 at 1:00PM;
- WHEREAS, bid opening immediately follows on the same day at 1:00 AM, the BAC chairman, Engr. Emmanuel Enrico A. de Vera presided the bid opening. The other members of the BAC were there namely; Ms. Maria Leonora S. Romarate, Ms. Mary Diana S. dela Cruz, Engr. Gerson L. Francisco and Engr. Edgardo E. dela Torre Jr. The representative of the bidders, Mr. Sergio Reguyal of the Joint Venture firm and the two (2) representative of ICP-FNET Engineering, Mr. Antonio Galvez and Mr. Thomas Carter III, were there and the BAC Secretariat, Ms. Marichu Ferrer and Ms. Charito S. Fernando;
- WHEREAS, the eligibility documents and the technical documents of the two bidders were examined and the BAC after thoroughly checked all the documents declared the two Bidders both eligible. For other additional documents required the representatives were informed to submit on or before the post qualification stage;

WHEREAS, the Financial documents were opened and read, the result is as follows:

WHEREAS, the total bid offered by C.T Leoncio Construction & Trading/SSR Construction (Joint Venture) was declared as the lowest bid as read and ICP-FNET Engineering's bid is the second lowest bid as read. The BAC chairman announced that necessary bid evaluation and post qualification will immediately follows;

Whereas, the BAC decided to make a synchronized post qualification process for the two bidders. On February 18, 2021, ICP-FNET Engineering at San Jose del Monte City, Bulacan was subjected to post qualification and on February 19, 2021, the Joint Venture C.T Leoncio Construction & Trading and SSR Construction were also subjected to post qualification. Both the two (2) bidders were declared Responsive based on the Post Qualification Report prepared by the BAC.

Whereas, during the bid evaluation on the Bill of Quantities (BOQ) submitted by the two (2) bidders, a correction was made to the BOQ of ICP-FNET Engineering as reflected in Appendix 10 of the Bid Evaluation Report (BER) which resulted to a decrease in the total bid price of the said company On the other hand, the bid price of the Joint Venture firm has been adjusted due to the adjustment in decimal point, the BAC had not notice any deficiency in the computation/BOQ. The total bid prices after bid evaluation were as follows:

Whereas, it is stated in RA 9184 Section 12 – Bid Evaluation, the BAC shall evaluate all bids on an equal footing to ensure fair and competitive bid comparison. Section 12.3 also states the following:

"In case of discrepancies between: (a) bid prices in figures and in words, the latter shall prevail; (b) total price of the item and unit price of the item as extended or multiplied by the quantity of that item, the latter shall prevail; (c) stated total price and the actual sum of prices of component items, the latter shall prevail; (d) unit cost in the detailed estimate and unit cost in the bill of quantities, the latter shall prevail".

WHEREAS, after all the examination and evaluation was done, the BAC confirmed that the company, ICP-FNET ENGINEERING, was capable financially, technically, and legally to implement the project, CIVIL WORKS FOR PIPELAYING AND RELATED WORKS. The company was declared Responsive in all aspects and proclaimed to be the LOWEST CALCULATED AND RESPONSIVE BID;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVED as it is hereby RESOLVED:

- a) To declare ICP-FNET ENGINEERING., with office address at Excelcrete Redimix, Andres Bijasa Road, Brgy. Gaya-Gaya, City of San Jose Del Monte, Bulacan as the Bidder whose bid was declared as the Lowest Calculated and Responsive Bid for the project, "CIVIL WORKS FOR PIPELAYING AND RELATED WORKS. And to recommend the contract award in the amount of Sixty Seven Million Seven Hundred Fifty Five Thousand Eight Hundred Pesos and 90/100 Only (Php67,755,800.90).
- b) To recommend for approval by the General Manager of the Santa Maria Water District the foregoing findings.
