- WHEREAS, the Santa Maria Water District BAC secretariat published In PhilGeps and SMWD's website an invitation to Bid for the above stated project for the period March 16 to 22, 2021. The same invitation was sent to three (3) observers such as Commission on Audit (COA), Soroptomist International of Santa Maria, and Bulacan Chamber of Commerce and Industry. The invitation was also posted in conspicuous premise of the Santa Maria Water District's office on the same period;
- WHEREAS, in response to the said invitation, only one manufacturer of uPVC pipes and elbows bought bidding documents and submitted the same on March 30, 2021 at 3:06 PM. It was submitted by Mr. Nestor F. Galisim, authorized representative of Atlanta Industries, Inc.;
- WHEREAS, prior to the bidding of this project, Atlanta Industries, Inc. was already declared eligible bidder last November 2020 for the project, Procurement of Pipes, Valves, and Fittings, an ADB Funded Project of SMWD. However, the BAC still checked and verified all the eligibility documents, it's completeness and if the documents were all updated. All the required documents were present and updated so the BAC moved in the opening of the Financial documents of the bidder where it has passed the preliminary examination of bids;
