## BAC RESOLUTION RECOMMENDING AWARD FOR THE PROJECT: PROCUREMENT OF VARIOUS VALVES REQUIREMENT OF SMWD FOR CY 2021 Reference No. PB2021-SMWD-G-007

- WHEREAS, the Santa Maria Water District BAC secretariat published In PhilGeps and SMWD's website an invitation to Bid for the above stated project for the period March 11 to 18, 2021. The same invitation was sent to three (3) observers such as Commission on Audit (COA), Soroptomist International of Santa Maria, and Bulacan Chamber of Commerce and Industry. The invitation was also posted in conspicuous premise of the Santa Maria Water District's office on the same period;
- WHEREAS, in response to the said invitation, only one manufacturer/dealer of Air Release valves, butterfly and gate valves bought bidding documents on March 24, 2021 and submitted the bidding documents on the same day at 11:20 AM.
- WHEREAS, prior to the bidding of this project, AVK Philippines, Inc. was already declared eligible bidder last November 2020 for the project, Procurement of Pipes, Valves, and Fittings, an ADB Funded Project of SMWD. However, the BAC still checked and verified all the eligibility documents, its completeness and if the documents were all updated. All the required documents were present and updated so the BAC moved in the opening of the financial documents of the bidder where it has passed the preliminary examination of bids;
