BAC RESOLUTION RECOMMENDING AWARD FOR THE PROJECT: PROCUREMENT OF VARIOUS BRASS AND GALVANIZED IRON (GI) FITTINGS REQUIREMENT OF SMWD FOR CY 2021 Reference No. PB2021-SMWD-G-009

WHEREAS, the Santa Maria Water District BAC secretariat published In PhilGeps and SMWD's website an invitation to Bid for the above stated project for the period March 29 to April 5, 2021. The same invitation was sent to three (3) observers such as Commission on Audit (COA), Soroptomist International of Santa Maria, and Bulacan Chamber of Commerce and Industry. The invitation was also posted in conspicuous premise of the Santa Maria Water District's office on the same period;

WHEREAS, in response to the said invitation, only one supplier of brass and galvanized iron (GI) fittings bought bid documents on April 15, 2021 in the amount stipulated in the Invitation to Bid of Ten Thousand Pesos (Php10,000.00). It submitted the bid documents on April 20, 2021 at 9:15 AM prior to bid opening at 1:00PM of the same day;

WHEREAS, all the eligibility and technical documents have thoroughly checked and scrutinized. All the required documents were present and updated so the BAC moved in the opening of the financial documents of the bidder where it has passed the preliminary examination of bids;

- To recommend for approval by the General Manager of the Santa Maria Water District the foregoing findings.


