THIS AGREEMENT, made this ______ day of May 2021 between **SANTA MARIA WATER DISTRICT** and **HYDRO PHIL ASIA, INC**.

KNOWN ALL MEN BY THESE PRESENTS:

SANTA MARIA WATER DISTRICT, a Government Owned and Controlled Corporation (GOCC) duly organized and existing under and by virtue of Presidential Decree No. 198, as amended, with principal office address at No. 3 M. de Leon St., Poblacion, Santa Maria, Bulacan, represented by its General Manager, **ENGR. CARLOS N. SANTOS, JR.**, duly authorized for this purpose, hereinafter called the **ENTITY**.

And -

HYDRO PHIL ASIA, INC., a duly organized and existing entity under and by virtue of the laws of the Republic of the Philippines, with principal office address at No. 393 G.P. Purok 3, Brgy. Lumang Bayan, Plaridel, Bulacan represented by its Vice President, RIC JHASON HERNANDEZ, hereinafter called the **SUPPLIER**.

WITNESSETH:

WHEREAS, in response to the **ENTITY's** Invitation to Bid, the **SUPPLIER** submitted its bid to the Procuring Entity to deliver **PROCUREMENT OF HDPE TUBING AND PLASTIC FITTINGS** for **SANTA MARIA WATER DISTRICT**;

WHEREAS, the bid of the SUPPLIER was the Single Calculated and Responsive Bid;

WHEREAS, the **ENTITY** has awarded the Contract to the **SUPPLIER** at the price stipulated in its winning BID of **ONE MILLION SEVENTY FOUR THOUSAND THREE HUNDRED TWENTY PESOS (PhP1,074,320.00)** inclusive of taxes.

WHEREAS, the Entity is desirous that the Supplier execute the project, "PROCUREMENT OF HDPE TUBING AND PLASTIC FITTINGS REQUIREMENT OF SMWD FOR CY 2021" (hereinafter called "the Goods") and the Entity has accepted the Bid for ONE MILLION SEVENTY FOUR THOUSAND THREE HUNDRED TWENTY PESOS (PhP1,074,320.00) by the Supplier for the supply and delivery of such Goods and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- 1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
- 2. The following documents shall be attached, deemed to form, and be read and construed as part of this Agreement, viz:
 - (a) the Bid Form and the Price Schedule submitted by the Bidder;
 - (b) the Schedule of Requirements;
 - (c) the Technical Specifications;

- (d) the General Conditions of Contract;
- (e) the Special Conditions of Contract;
- (f) the Entity's Notification of Award;
- (g) the Performance Security; and
- (h) Other contract documents that may be required by existing laws and/or the Entity.
- In consideration of the payments to be made by the Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Entity to provide the goods and services and to remedy defects therein in conformity in all respects with the provisions of the Contract.
- 4. The Entity hereby covenants to pay the Supplier in consideration of the provision of the goods and services and the remedying of defects wherein, the Contract Price or such other sum as may become payable under the provisions of this Contract at the time and in the manner prescribed by this Contract.
