CONTRACT AGREEMENT

THIS AGREEMENT, made this 10th day of May 2021 between SANTA MARIA WATER DISTRICT and ICP-FNET ENGINEERING.

KNOWN ALL MEN BY THESE PRESENTS:

SANTA MARIA WATER DISTRICT, a Government Owned and Controlled Corporation (GOCC) duly organized and existing under and by virtue of Presidential Decree No. 198, as amended, with principal office address at No. 3 M. de Leon St., Poblacion, Santa Maria, Bulacan, represented by its General Manager, **ENGR. CARLOS N. SANTOS, JR.**, duly authorized for this purpose, hereinafter called the **ENTITY**.

And-

ICP-FNET ENGINEERING a duly organized and existing entity under and by virtue of the laws of the Republic of the Philippines, with principal office address at No. 187 San Jose – Bocaue Road, Tungkong Mangga, City of San Jose Del Monte (SJDM), Bulacan, represented by its Owner/General Manager, **ISIDRO C. PAREDES**, hereinafter called the **CONTRACTOR**.

WITNESSETH:

WHEREAS, in response to the ENTITY's Invitation to Bid, the **CONTRACTOR** submitted its bid to the Procuring Entity to implement the project, **CIVIL WORKS FOR PIPELAYING AND RELATED WORKS** for **SANTA MARIA WATER DISTRICT**;

WHEREAS, the bid of the **CONTRACTOR** was the **Lowest Calculated and Responsive Bid**;

WHEREAS, the ENTITY has awarded the Contract to the **CONTRACTOR** at the price stipulated in its winning BID of **SIXTY SEVEN MILLION SEVEN HUNDRED FIFTY FIVE THOUSAND EIGHT HUNDRED PESOS AND NINETY CENTAVOS (PhP67,755,800.90)** broken down as follows:

PhP67,755,800.90 (Inclusive of Taxes)

PhP 4,234,737.56 (Taxes)

PhP63,521,063.34 (Exclusive of Taxes)

WHEREAS, the Entity is desirous that the Contractor execute the project, "**CIVIL WORKS FOR PIPELAYING AND RELATED WORKS**" (hereinafter called "the Works") and the Entity has accepted the Bid for **SIXTY SEVEN MILLION SEVEN HUNDRED FIFTY FIVE THOUSAND EIGHT HUNDRED PESOS AND NINETY CENTAVOS (PhP67,755,800.90)** by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.

2. The following documents shall be attached, deemed to form, and be read and construed as part of this Agreement, viz:
 - (a) General and Special Conditions of Contract;
 - (b) Drawing/Plans;
 - (c) Specifications;
 - (d) Invitation to Bid;
 - (e) Instruction to Bidders;
 - (f) Bid Data Sheet;
 - (g) Supplemental/Bid Bulletin
 - (h) Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation.
 - (i) Eligibility Requirements/Documents.
 - (j) Performance Security
 - (k) Notice of Award of Contract and the Bidder's conforme thereto.
 - (l) Other contract documents that may be required by existing laws and/or the Entity.

3. In consideration of the payments to be made by the Entity to the Contractor as hereinafter mentioned, the Contractor hereby covenants with the Entity to execute and complete the Works and remedy any defects therein in conformity with the provisions of this Contract in all respects.

4. The Entity hereby covenants to pay the Contractor in consideration of the execution and completion of the Works and the remedying of defects wherein, the Contract Price or such other sum as may become payable under the provisions of this Contract at the times and in the manner prescribed by this Contract.
