



## BAC RESOLUTION NO. BCR-2021-010-A

**BAC RESOLUTION RECOMMENDING AWARD OF CONTRACT TO BNCD LUMBER AND HARDWARE FOR THE PROJECT, PROCUREMENT OF CEMENT**

WHEREAS, on January 8 and 13, 2021 the Construction & Maintenance and Engineering Division have requested for the procurement of cement thru Purchase Requests nos. CMD-2021-01-002 to 004 and ENGG-2021-01-002 for SMWD's Various Projects for the year 2021. The P.Rs were then approved by the Head of the Procuring Entity (HOPE) to start the procurement activity;

WHEREAS, the project is included in the APP for the year 2021 with a total Approved Budget for the Contract (ABC) amounting to Eight Hundred Thirty Three Thousand Five Hundred Twenty Pesos (Php833,520.00.00) to be procured pursuant to Section 52.1 (b) Shopping of 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No.9184;

WHEREAS, the procurement activity has been initiated by the procurement section and thereby published the RFQ in Philgeps for seven (7) consecutive days from January 29 to February 4, 2021 with PhilGEPS Reference Number 7437935. The RFQ was likewise posted in the website of the Procuring Entity;

WHEREAS, three (3) suppliers of known qualifications submitted quotation and on February 4, 2021 after the advertisement was put to a close, an Abstract of Quotation (AOQ # A2021-020) has been prepared for verification of the offer. The offer of the three (3) suppliers did not exceed the Approved Budget of the Contract, to wit:




