BAC RESOLUTION RECOMMENDING AWARD FOR THE PROJECT: PROCUREMENT FOR THE RENTAL OF HEAVY EQUIPMENT – MINI BACK HOE AND MINI DUMP TRUCK Reference No. WR# CMD-2021-01-001

WHEREAS, the Construction and Maintenance Division had submitted a Work Request requesting for rental of the following equipment:

- 1. Mini Back Hoe
- 2. Mini Dump Truck
- WHEREAS, the project is included in the 2021 Annual Procurement Plan with an approved budget of Four Hundred Eighty Nine Thousand Seven Hundred Seventeen Pesos and Fifty Centavos (PhP489,717.50) for the complete duration of the project;
- WHEREAS, Mini Back Hoe will be used for breaking of concrete pavements while Mini Dump Truck will be used for hauling of excess backfill materials from project sites to designated dumping area;
- WHEREAS, rental of heavy equipment covers the following various extension projects of the SMWD for calendar year 2021:
 - Brgy. Parada Sidestreet Ext. Project (Caybanban St.-Sto. Niño Parish Church to Basketball Court).
 - 2. Brgy. Parada Sidestreet Ext. Project (Sapa, J. de Jesus Street)
 - 3. Brgy. Tumana Sidestreet Ext. Project (Papaya Street)
 - 4. Brgy. Tumana Sidestreet Ext. Project (Pakwan Street)
 - 5. Brgy. Sto. Tomas Road Mainline Ext. Proj. (Casa de Bambini School to Chexers)
 - 6. Brgy. Poblacion Sidestreet Ext. Project (Laguerta)
 - 7. Brgy. Guyong Sidestreet Ext. Project (Celestino Street)
 - 8. Brgy. Pulong Buhangin Sidestreet Ext. Proj. (Maningas Street)
- WHEREAS, Request for Quotation (RFQ) has been prepared and published in Philgeps website for three (3) consecutive times. The first one on March 1-4, 2021, second posting on March 9-12, 2021 and the third one on March 17-22, 2021. The same RFQ was also posted in the website of the SMWD;
- WHEREAS, three (3) lessors of heavy equipment submitted quotations, namely: Grupo Torre Construction, Third King Enterprises, and EDN Builders Supply. However, EDN Builders Supply was found that it has no PhilGeps Registration No. which is one of the documentary requirements as listed in the Request for Quotation. For this reason, EDN Builders Supply, was declared ineligible, and was delisted in the Abstract of Quotation;

WHEREAS, the two (2) other lessors were both declared eligible and their quotations were as follows;

- b) To declare **THIRD KING ENTERPRISES**, with office address at 311 Brgy. Balasing, Santa Maria, Bulacan, whose offer is the single calculated and responsive quotation for the rental of Mini Back Hoe with Breaker for One Thousand Three Hundred Pesos (PhP1,300.00) per hour.
- c) To recommend for approval by the General Manager of the Santa Maria Water District the foregoing findings.

CONTRACT AGREEMENT CA-2021-05-023

PROJECT: RENTAL OF HEAVY EQUIPMENT , MINI BACK HOE, FOR VARIOUS SIDESTREET EXTENSION PROJECTS OF SMWD FOR CY 2021

This heavy equipment rental agreement is made and effective by and between:

SANTA MARIA WATER DISTRICT, with office address at #3 M. de Leon St., Poblacion, Santa Maria, Bulacan 3022, represented by its General Manager, **ENGR. CARLOS N. SANTOS**, **JR**. and herein referred to as the LESSEE.

and

THIRD KING ENTERPRISES, with office address at No. 311 Brgy. Balasing, Santa Maria, Bulacan represented by its President, **MR. RAUL GRAVADOR** and herein referred to as the LESSOR.

The LESSOR hereby leases to LESSEE, and LESSEE hereby leases from the LESSOR, the following described equipment (the "Equipment").

 - 5. Brgy. Sto. Tomas Road Mainline Ext. Proj. (Casa de Bambini School to Chexers)
 - 6. Brgy. Poblacion Sidestreet Ext. Project (Laguerta)
 - 7. Brgy. Guyong Sidestreet Ext. Project (Celestino Street)
 - 8. Brgy. Pulong Buhangin Sidestreet Ext. Proj. (Maningas Street)
- 2. The Mini Back Hoe shall be used for breaking of concrete pavements during the implementation of various sidestreet extension projects.
- 3. The rental fee for the Equipment shall be paid on a weekly basis base on progress payment.
 - > P1,300.00 per hour of service
 - Inclusive of operator & diesel
 - The start of works will be from 8:00 A.M to 5:00 P.M
- 4. The cost of mobilizing the equipment to the job site shall be at the account of the contractor/lessor.
- 5. The driver's wage shall be at the account of the LESSOR.
- 6. All consumables including fuel, oils and others are at the expense of the LESSOR.

- 7. The Equipment shall be under the full control and supervision of the LESSOR.
- 8. The LESSOR shall be responsible for the breaking of concrete pavements during the implementation of the extension projects
- 9. The LESSEE shall not assign this Agreement or its interest in the Equipment without the prior written consent of the LESSOR.
- 10. The invalidity or unenforceability of any provision in this Agreement shall not cause any other provision to be invalid or unenforceable.
- 11. This Agreement shall be construed and enforced according to the existing laws of the Republic of the Philippines. This instrument constitutes the entire agreement between the parties on the subject matter hereof and it shall not be amended, altered or changed except by a further writing signed by the parties hereto.
- 12. The Terms of Reference, Notice of Award and Notice to Proceed shall be deemed an integral part of this contract.
