BAC RESOLUTION RECOMMENDING AWARD OF CONTRACT TO I-TECH INDUSTRIAL SALES

- WHEREAS, the Water Resource Division has prepared a Purchase Request for the procurement of Submersible Pump for immediate replacement at Pump Station No. 7 Sitio Bato, Guyong;
- WHEREAS, the project is included in the APP for the year 2021 with a total Approved Budget for the Contract (ABC) amounting to Two Hundred Fifty rine Thomas Sciently by Price (Php. 259, 071.00), per piece to be procured thru Negotiated Procurement-Emergency Cases;
- WHEREAS, the procurement activity has been initiated by directly negotiating with a supplier with technical, legal and financial capability to deliver the goods and execute the works to address the emergency;
- WHEREAS, I-Tech Industrial Sales submitted its offer with an amount of Two Hundred Fifty Nine Thousand Seventy One Pesos (Php259,071.00) per unit together with the documentary requirements. The offer exceeded the Approved Budget of the Contract but was justified because it was realized that the budget was for the submersible pump SP46-9, the end user required the technical specification of a submersible pump SP30-15 as stated in their request;
- WHEREAS, the Water Resource Division was required to adjust or realign the budget to augment the budget deficiency for this procurement. The Project Procurement Management Plan (PPMP) has to be updated;
- WHEREAS, upon confirmation and ascertainment of the capability of the supplier to address the emergency, I-Tech Industrial Sales was declared responsive and the offer was found advantageous to the Procuring Entity;
- NOW, THEREFORE, with the foregoing findings, we, the members of the BAC, hereby RESOLVE, as it is hereby RESOLVED, to recommend to the Head of Procuring Entity (HOPE) the award of the project, **Supply and Delivery of one (1) pcs. Submersible Pump** to **I-TECH INDUSTRIAL SALES** with the contract price of Two Hundred Fifty Nine Thousand Seventy One Pesos (Php259,071.00)


