WHEREAS, an invitation to Bid for the above stated project was published in PhilGEPS and SMWD's website for a period of seven (7) calendar days from July 22-29, 2021. The same invitation was sent to three (3) observers such as Commission on Audit (COA), Soroptomist International of Santa Maria, and Bulacan Chamber of Commerce and Industry. The invitation was also posted in conspicuous premise of the Santa Maria Water District's office on the same period;

WHEREAS, in response to the said invitation, two (2) legitimate suppliers of brass and galvanized iron (GI) fittings bought bidding documents and submitted the same on August 11, 2021 prior to bid opening as follows:
