- WHEREAS, the Santa Maria Water District BAC secretariat published In PhilGEPS and SMWD's website an invitation to Bid for the above stated projects for the period August 10-16, 2021. The same invitations were sent to three (3) observers and were also posted at conspicuous premise of the Santa Maria Water District's office on the same period;
- WHEREAS, in response to the said invitation, only one (1) prospective bidder purchased and submitted bidding documents prior to Bid Opening on August 31, 2021. The bidding documents were submitted by Mr. Ryan Astrero of Aluminates Metering Supply Co., Inc. on August 31, 2021 at 11:30 PM;
- WHEREAS, the eligibility documents of the bidder, were opened and passed the preliminary examination of bids. The SMWD BAC after thoroughly checked and verified all the documents, Eligibility and Technical, declared **Aluminates Metering Supply Co., Inc.** eligible to bid, and thus the BAC proceeded in opening the Financial Envelope;
