## **BAC Resolution Recommending Award of Project**

- WHEREAS, the Santa Maria Water District has an approved loan from the Asian Development Bank to finance the cost of the above stated project. The approved budget for the contract is Thirty Seven Million Eight Hundred Twenty Thousand Pesos (P37,820,000.00);
- WHEREAS, the Invitation to Bid for the project was published in website of Philippine Government Electronic Procurement System (PhilGEPS) and SMWD's website on February 19, 2021. The invitation was likewise sent to Commission on Audit (COA), Bulacan Chamber of Commerce and Philippine Institute of Civil Engineers (PICE) to observe and witness the stages of bidding activities;
- WHEREAS, Pre-bid conference and site visit were held on March 10, 2021 and March 12, 2021 respectively. Four (4) potential bidders attended the pre-bid and site visit;
- WHEREAS, the receipt of bids was closed at 10:00 AM local time on March 25, 2021 as per Supplemental Bid Bulletin No. 2021-005, dated March 18, 2021. Only one bidder submitted bid, it was Global Supply Solutions Corporation (GSSC);
- WHEREAS, the project is a Single-Stage: Two-Envelope Bidding Procedure and the single bid was opened on the same day at 10:00AM. LWUA and CDTA representatives attended the opening through Zoom Link. The BAC examined and checked the eligibility and Technical proposal of GSSC and found that all the necessary documents required are complete and in order. Global Supply Solutions Corporation, the lone bidder, was able to meet the qualifications listed on the ADBendorsed version of the Bidding Documents and was declared eligible;
- WHEREAS, the First Stage Bid Evaluation Report (Technical Proposals) for this project was submitted to Engr. Juanito M. Pagulayan Jr., Project Manager-LWUA ADB WDDSP through electronic means (email) on June 4, 2021 in accordance with the provisions of the loan Agreement;
- WHEREAS, on June 29, 2021, the BAC received ADB's No Objection Letter (NOL) to the Santa Maria WD Package CWO5b Technical BER and the BAC was advised to proceed with the opening of the Financial Bid of Global Supply Solutions Corporation and submit the Financial BER for ADB's review and issuance of No Objection;
- WHEREAS, on July 8, 2021 at 11:00 AM, the BAC proceeded to the Second Stage of the Bidding Process, the opening of the Financial Proposal of Global Supply Solutions Corporation. The opening was witnessed by three (3) representative of the bidder (ref. Minutes of the Opening of the Financial Bid):
- WHEREAS, the Financial Documents of the sole bidder was satisfactory as all financial documents such as Letter of Price Bid, Schedule of Rates and Prices for Plant and Mandatory Spare Parts Supplied, Design Service, Civil Works and Other Services and Grand Summary were all signed. The total bid

is Thirty Seven Million One Hundred Forty-Five Thousand Six Hundred Thirty Three Pesos and 12/100 (Php37,145,633.12). There is no correction in the financial bidding documents of the bidder;

- WHEREAS, the Second Stage Bid Evaluation Report (Financial Proposal) for this project was submitted to Engr. Juanito M. Pagulayan Jr., Project Manager-LWUA ADB WDDSP through electronic means (email), on August 2, 2021 in accordance with the provisions of the loan Agreement;
- WHEREAS, on August 5, 2021, the BAC received ADB's No Objection Letter (NOL) to the Santa Maria WD Package CWO5b Financial BER and to recommend award of contract to Global Supply Solutions Corporation at the total contract price of Thirty Seven Million One Hundred Forty Five Thousand Six Hundred Thirty Three Pesos and 12/100 (Php37,145,633.12);

And to recommend the contract award in the amount of Thirty Seven Million One Hundred Forty Five Thousand Six Hundred Thirty Three Pesos and 12/100 (Php37,145,633.12);
