BAC RESOLUTION RECOMMENDING AWARD OF CONTRACT TO JEMA FUTURE-BEST ENTERPRISE AND ALUMINATES METERING SUPPLY CO., INC.

FOR THE PROJECTS:

- SUPPLY AND DELIVERY OF BRASS AND GI FITTINGS REQUIREMENT OF THE SMWD FOR CY 2022**

- SUPPLY AND DELIVERY OF CLASS “B” WATER METERS REQUIREMENT OF THE SMWD FOR CY 2022**

WHEREAS, the Santa Maria Water District BAC secretariat published In PhilGEPS and SMWD’s website an invitation to Bid for the above stated projects for the period February 2 to 9, 2022. The same invitations were sent to three (3) observers such as Commission on Audit (COA), Bulacan Chamber of Commerce and Soroptomist International of Santa Maria, Bulacan. The same invitations were also posted at conspicuous premise of the Santa Maria Water District’s office on the same period;

WHEREAS, in response to the said invitation, only one (1) prospective bidder for each project purchased and submitted bidding documents prior to Bid Opening on February 22, 2022. For the supply of brass and G.I fittings, Mr. Vincent Ursulom, representative of **Jema Future-Best Enterprise** submitted the bidding documents together with samples of fittings. For the supply of water meters, Mr. Vincent Ryan Astrero of **Aluminates Metering Supply Co., Inc.**, submitted the bidding documents together with one (1) pc water meter as sample;

WHEREAS, the eligibility and technical documents of both bidders, were opened and passed the preliminary examination of bids. The documents were thoroughly checked and verified. The BAC found that all the documents were complete and in order from Philgeps Registration, Mayor’s Permit, Tax Clearance, NFCC, Financial Statements, Omnibus Sworn Statements to technical documents such as on-going and single largest completed projects. Both bidders submitted Bid Securing Declaration as form of bid securities;

WHEREAS, the technical team, Engr. Gerson Francisco and Mr. Mark Lackie Porciuncula, inspected the various Brass and GI fittings brought by the bidder, Mr. Vincent Ursulom and also the sample water meter brought by Mr. Astrero. It was assessed that the fittings and water meter are both compliant with the technical specifications as required in the bidding documents;

WHEREAS, the bidders, **Jema Future-Best Enterprise and Aluminates Metering Supply Co., Inc.**, were both declared eligible to bid, thus, the BAC proceeded in opening the financial envelope of both bidders;

WHEREAS, post-qualification was conducted on February 24, 2022 to all the eligibility, technical and financial documents submitted by the bidders wherein careful examination, validation and verification were done by the BAC. A Verification from the clients of **JFBE** was done through telephone conversation with Guinayangan Water District (042-717-6027) and Metro Roxas Water District (036-621-0044). It was confirmed that JFBE has long been their supplier of Brass and GI fittings and both clients have positive comments on JFBE;

WHEREAS, same thing was done to **AMSCI** during the post qualification stage. It's capability of delivering the goods was confirmed by its client Puerto Princesa City Water District at Palawan (048-433-6802) AMSCI has also been an accredited supplier of the SMWD for so many years now, the integrity and quality of the water meters have already been trusted;

WHEREAS, **JEMA FUTURE-BEST ENTERPRISE AND ALUMINATES METERING SUPPLY CO. INC.**, were both found to have complied in all aspects and both have the capacity legally, technically and financially to implement the projects. The SMWD BAC, hence, declared the bidders both **responsive**;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby **RESOLVED** as it is hereby **RESOLVED**:

1. To declare **JEMA FUTURE-BEST ENTERPRISE** with office address at No. 15 Via Pisa St., Villa Firenze Subd., Tandang Sora, Quezon City as the Bidder whose bid is the Single Calculated and Responsive Bid for the project, **SUPPLY AND DELIVERY OF BRASS AND G.I FITTINGS REQUIREMENT OF THE SMWD FOR CY 2022**. And to recommend the contract award in the amount of **Ten Million Five Hundred Forty One Thousand Seven Hundred Fourteen Pesos (PhP10,541,714.00)**.
2. To declare **ALUMINATES METERING SUPPLY CO., INC.** with office address at No. 4S Malaya Street, Malanday, Marikina City as the Bidder who is the Single Calculated and Responsive Bid for the project, **SUPPLY AND DELIVERY OF CLASS "B" WATER METERS REQUIREMENT OF THE SMWD FOR CY 2022**. And to recommend the contract award in the amount of **EIGHT MILLION TWO HUNDRED FORTY FIVE THOUSAND PESOS (P 8,245,000.00)**.
3. To recommend for approval by the General Manager of the Santa Maria Water District the foregoing findings.
