SUPPLY AND DELIVERY OF BRASS AIR RELEASE VALVE AND D.I GATE VALVES REQUIREMENT OF THE SMWD FOR CY 2022

Reference No. PB2022-SMWD-G-03-005

This supplemental/Bid Bulletin is issued to all prospective bidders to clarify, modify and/or amend items in the Bidding Documents as discussed and agreed during the Pre-bid Conference held on March 3, 2022 for the above stated project.

This shall form an integral part of the bidding documents.

Clarification and Addendum on the Bidding Documents:

1. Clarification on the invitation to bid if the invitation is for manufacturer only:
 - **BAC clarified that the bidding for this project is open for manufacturers only.**
2. As per stated in BDS Clause 5.1 – Warranty period is three (3) months to one (1) year after acceptance by the Procuring Entity of the delivered goods.
 - **BAC clarified that the minimum period of warranty is one (1) year, but bidders could offer more than the warranty period required, which is more advantageous to the Procuring Entity.**
3. **For Technical Specifications:**
 - a. The bidders shall bring cut away sample or cutaway model of the smallest size gate valve.
 - b. The bidders can use different terminologies but shall see to it that the materials are equal with the specifications required and have equal functions.
 - c. The delivered items will be subjected to testing, if the items failed, the whole batch delivered will not be accepted and shall be replaced within thirty (30) days.
 - d. Short Body ductile iron fittings shall conform to the requirements of the “Ductile Iron Pipes, Special Castings and Ductile Iron Parts for Pressure Main Lines”(ISO R13).
 - e. For Air Release Valve, the BAC will stick with the technical specifications stated in the bidding documents.
4. The lead time for delivery of items is fifteen (15) days upon receipt of P.O.
 - **The BAC clarified that should the items be delivered more than the allotted time for delivery, the bidder/supplier shall make a letter requesting for the extension of delivery.**
5. Eligibility and Technical Documents
 - **The BAC chairman reiterated that pass/fail criteria will be implemented which mean that absence of any of the enumerated eligibility, technical & financial document shall be a ground for disqualification of the bidder.**
6. **For Statement of Compliance with Technical Specifications:**
 - **The BAC chairman advised that the bidder may add on another column for the Statement of Compliance or Non Compliance to Technical Specifications**
