## BAC RESOLUTION RECOMMENDING AWARD OF CONTRACT TO CHEMICAL RESEARCH PRODUCTS INDUSTRIAL SALES, INC.

## PROCUREMENT OF CALCIUM HYPOCHLORITE AND CHLORINE DIOXIDE LIQUID REQUIREMENTS OF THE SMWD FOR CY 2022

- WHEREAS, the Santa Maria Water District BAC secretariat published In PhilGEPS and SMWD's website an invitation to Bid for the above stated projects for the period January 11-18 2022. The same invitations were sent to three (3) observers such as Commission on Audit (COA), Bulacan Chamber of Commerce and Soroptomist International of Santa Maria, Bulacan. The same invitations were also posted at conspicuous premise of the Santa Maria Water District's office on the same period;
- WHEREAS, in response to the said invitation, only one (1) prospective bidder purchased and submitted bidding documents prior to Bid Opening on January 31, 2022. The prospective bidder is **Chemical Research Products Industrial Sales, Inc. (CHEMRES)** represented by Ms. Marissa Directo. Ms. Directo submitted bidding documents on January 31, 2022 at 9:50AM;
- WHEREAS, on the same day January 31, 2022 at 1:00PM, the Bids and Awards Committee started the opening of bids. The eligibility and technical documents, were opened and passed the preliminary examination of bids. The documents were thoroughly checked and verified. The BAC found that all the documents were complete and in order from Philgeps Registration, Mayor's Permit, Tax Clearance, NFCC, Omnibus Sworn Statements to technical and financial documents. The Bid Security is a Surety Bond issued by Stronghold Corporation and is valid for one hundred twenty (120) calendar days upon opening of bids;

WHEREAS, the sole bidder, **CHEMRES**., was declared eligible to bid, thus, the BAC proceeded in opening the financial envelope;

WHEREAS, post-qualification was conducted on February 2, 2022 to March 9, 2022 to all the eligibility, technical and financial documents submitted by the bidders wherein careful examination, validation and verification were done by the BAC. The test analysis for the chlorine content of the calcium hypochlorite offered by the bidder was also done at PIPAC laboratory and the result is positive, 70% chlorine content, as required by the Procuring Entity;

WHEREAS, CHEMICAL RESEARCH PRODUCTS INDUSTRIAL SALES. INC., was found to have complied in all aspects of bidding and has the capacity legally, technically and financially to implement the project. The SMWD BAC, hence, declared the bidder responsive and the bid was proclaimed, SINGLE CALCULATED AND RESPONSIVE BID;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVED as it is hereby RESOLVED:

- To declare CHEMICAL RESEARCH INDUSTRIAL SALES, INC., with office address at 475 J.P. Rizal Street, Mahabang Parang, Santa Maria, Bulacan as the Bidder whose bid is the Single Calculated and Responsive Bid for the project, PROCUREMENT OF CALCIUM HYPOCHLORITE AND CHLORINE DIOXIDE LIQUID REQUIREMENTS OF THE SMWD FOR CY 2022. And to recommend the contract award in the amount of Three Million Eighty Three Thousand Six Hundred Seventy Pesos (PhP3,083,670.00).
