### KNOW ALL MEN BY THESE PRESENTS:

This Agreement made and executed this 14th day of March 2022 at Santa Maria, Bulacan by and between:

**SANTA MARIA WATER DISTRICT**, a government owned and controlled corporation duly organized and existing under and by virtue of the laws of the Republic of the Philippines, with business address at # 3 de Leon St., Poblacion, Santa Maria, Bulacan, represented herein by its General Manager, **ENGR. CARLOS N. SANTOS, JR.**, hereinafter referred to as the "**Client**"

-and-

**TOYOTA BALINTAWAK, INC.**, a private company organized and existing and licensed under Philippine laws with business address at EDSA cor. V. Ang & Gen Evangelista St., 136 Caloocan City, represented by its Service Manager, **MR. ROBERTO CRUZ**, hereinafter referred to as the "**Contractor**".

### WITNESSETH:

WHEREAS, the **Client** is desirous that the **Contractor** perform the **Repairs and Maintenance Services** hereinafter called "**the Works**" and the Client have to pay the Contractor for the actual cost of the Repairs and Maintenance executed and performed by the Contractor in the completion of such works and the remedying of any defects therein.

WHEREAS, the **Contractor**, offered a price of One Hundred Thirteen Thousand Pesos (Php113,000.00) which is intended for the whole duration of the contract but the payment shall be based on the actual works performed and completed. Thus, the payment for the whole duration of the contract shall not exceed One Hundred Thirteen Thousand Pesos (Php113,000.00)

NOW, THEREFORE, THE PARTIES hereby agree as follows:

1. The Contractor shall perform the Services, the scope of work and other concern as specified in the "Terms of Reference," which was made as an integral part of this Contract
2. The Contractor shall perform the Services stipulated in the Terms of Reference (TOR) during the period commencing **April 1, 2022 and continuing through December 31, 2022**, or any other period as maybe subsequently agreed upon by the parties in writing.
3. In consideration of the payments to be made by the Client to the Contractor as hereinafter mentioned, the Contractor hereby covenants with the Client to provide the Services and to remedy defects therein in conformity in all respects with the provisions of the Contract and Terms of Reference.
4. The Client hereby covenants to pay the Contractor in consideration of the provision of the Works that will be satisfactorily performed the sum as may become payable under the provisions of this Contract at the time and in the manner prescribed in the Terms of Reference.
