KNOWN ALL MEN BY THESE PRESENTS:

SANTA MARIA WATER DISTRICT, a Government Owned and Controlled Corporation (GOCC) duly organized and existing under and by virtue of Presidential Decree No. 198, as amended, with principal office address at No. 3 M. de Leon St., Poblacion, Santa Maria, Bulacan, represented by its General Manager, **ENGR. CARLOS N. SANTOS**, **JR.**, duly authorized for this purpose, hereinafter called the **ENTITY**.

And-

KPI ELEVATORS, INC., a duly organized and existing entity under and by virtue of the laws of the Republic of the Philippines, with principal office address at Mc Arthur Highway, Primus Medicus Corporation Center, Brgy. San Isidro, San Fernando, Pampanga, represented by its Authorized Representative, **VINCENT AMOR C. MACOY,** hereinafter called the **CONTRACTOR**.

WITNESSETH:

WHEREAS, the Entity is desirous that the Supplier execute the project, "SUPPLY, DELIVERY, INSTALLATION, TESTING AND COMMISSIONING OF BRAND NEW PASSENGER LIFT (hereinafter called "the Goods;

WHEREAS upon careful evaluation of the proposal, legal, financial and technical capacity of the CONTRACTOR, the entity declared the CONTRACTOR to be FINANCIALLY, LEGALLY AND TECHNICALLY capable to implement the project in pursuant to Guidelines for Negotiated Procurement under TWO FAILED BIDDINGS Annex H of RA 9184.

WHEREAS, the Entity has accepted the Bid for **TWO MILLION FIVE HUNDRED THOUSAND PESOS (PhP2,500,000.00)** by the Contractor for the execution and completion of such works and the remedying of any defects therein.

WHEREAS, the terms of payment shall be as follows:

- 15% Down Payment within 15 days upon receipt of Notice to Proceed (NTP).
- 50% Payable upon delivery of the equipment at the site.
- 15% Payable upon 50% completion of installation
- 15% Payable upon 100% completion of installation
- 5% Payable after testing and commissioning and upon handing-over of
- the permit to operate

100% complete payment





NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- 1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
- 2. The following documents shall be attached, deemed to form, and be read and construed as an integral part of this Contract Agreement, viz:
 - (a) the Detailed Cost Outline of Cost/Bid Amount;
 - (b) Bill of Quantities
 - (c) Compliance to Technical Specifications
 - (d) the proposal of the contractor with ref. no. 0009944231 dated April 24, 2022
 - (e) Eligibility Documents
 - (f) the Entity's Notification of Award;
 - (g) the Performance Security;
 - (h) Notice to Proceed; and
 - (i) Other contract documents that may be required by the existing laws and/or entity.
- 3. In consideration of the payments to be made by the Entity to the Contractor as hereinafter mentioned, the Contractor hereby covenants with the Entity to provide the goods and services and to remedy defects therein in conformity in all respects with the provisions of the Contract.
- 4. The Entity hereby covenants to pay the Contractor in consideration of the provision of the goods and services and the remedying of defects wherein, the Contract Price or such other sum as may become payable under the provisions of this Contract at the time and in the manner prescribed by this Contract.
- 5. The completion of the Works is required within one hundred twenty (120) calendar days from receipt of the Notice to Proceed
