

CONTRACT AGREEMENT CA-2022-07-026

Project: SUPPLY, DELIVERY, INSTALLATION, TESTING AND COMMISSIONING OF ADDITIONAL AIR CONDITIONING
UNITS FOR THE SANTA MARIA WATER DISTRICT

THIS AGREEMENT, made this 15th day of July 2022 between **SANTA MARIA WATER DISTRICT** and **ACMI OFFICE SYSTEMS PHILIPPINES, INC.**

KNOWN ALL MEN BY THESE PRESENTS:

SANTA MARIA WATER DISTRICT, a Government Owned and Controlled Corporation (GOCC) duly organized and existing under and by virtue of Presidential Decree No. 198, as amended, with principal office address at No. 3 M. de Leon St., Poblacion, Santa Maria, Bulacan, represented by its General Manager, ENGR. CARLOS N. SANTOS, JR., duly authorized for this purpose, hereinafter called the ENTITY.

And-

ACMI OFFICE SYSTEMS PHILIPPINES, INC., a duly organized and existing entity under and by virtue of the laws of the Republic of the Philippines, with principal office address at AYSN Building, No. 268-A N. Domingo St., San Juan, Metro Manila, represented by its duly authorized representative, **ROSEMARIE DELA CRUZ** hereinafter called the **SUPPLIER**.

WITNESSETH:

WHEREAS, in response to the ENTITY'S Invitation to Bid, the **SUPPLIER** submitted its bid to the Procuring Entity to implement the project, **SUPPLY**, **DELIVERY**, **INSTALLATION**, **TESTING AND COMMISSIONING OF ADDITIONAL AIR CONDITIONING UNITS FOR THE SANTA MARIA WATER DISTRICT**;

WHEREAS, the bid of the SUPPLIER was the Single Calculated and Responsive Bid;

WHEREAS, the ENTITY has awarded the Contract to the **SUPPLIER** at the price stipulated in its winning BID of **TWO MILLION FIVE HUNDRED TWENTY FOUR THOUSAND NINE HUNDRED TWENTY PESOS (PhP2,524,920.00)** inclusive of taxes.

WHEREAS, the Entity is desirous that the Supplier execute the project, "SUPPLY, DELIVERY, INSTALLATION, TESTING AND COMMISSIONING OF VARIOUS AIR CONDITIONING UNITS FOR THE SANTA MARIA WATER DISTRICT" (hereinafter called "the Goods") and the Entity has accepted the Bid for TWO MILLION FIVE HUNDRED TWENTY FOUR THOUSAND NINE HUNDRED TWENTY PESOS (PhP2,524,920.00) by the Supplier for the supply and delivery of such Goods and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- 1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
- 2. The following documents shall be attached, deemed to form, and be read and construed as part of this Agreement, viz:

- Warranty Certificate/After-Sales Service Parts (e)
- **Manpower Requirements** (f)
- the General Conditions of Contract; (g)
- the Special Conditions of Contract; (h)
- the Entity's Notification of Award; (i)
- (j) the Performance Security; and
- Other contract documents that may be required by existing laws and/or the Entity. (k)
- In consideration of the payments to be made by the Entity to the Supplier as hereinafter mentioned, 3. the Supplier hereby covenants with the Entity to completely implement/execute the project, "SUPPLY, DELIVERY, INSTALLATION, TESTING AND COMMISSIONING OF ADDITIONAL AIR CONDITIONING UNITS FOR THE SANTA MARIA WATER DISTRICT", identified in the bidding documents and to remedy defects therein in conformity in all respects with the provisions of the Contract.
- The duration of contract shall be for thirty (30) days and the location is the SMWD's New Building 4. located at No. 301 J.P. Rizal St., Poblacion, Santa Maria, Bulacan.
- 5. The Entity hereby covenants to pay the Supplier in consideration of the provision of the goods and services and the remedying of defects wherein, the Contract Price or such other sum as may become payable under the provisions of this Contract at the time and in the manner prescribed by this Contract.
