## BAC RESOLUTION RECOMMENDING AWARD OF CONTRACT TO PLATINUM RESEARCH LABORATORY, INC.

WHEREAS, the Water Resource Division has prepared a Work Request No. WR-2022-03-003 dated March 11, 2022 for the procurement of a Service Provider for Total Fecal, Total Coliform and Heterotropic Plate Count Test, Physical and Chemical Analysis (12 parameters) of water samples to ensure compliance of product water with the PNSDW. The WR was then approved by the HOPE on March 14, 2022;

WHEREAS, the project is included in the APP for the year 2022 with a total Approved Budget for the Contract (ABC) amounting to Nine Hundred Thirty-Three Thousand Five Hundred Pesos (P933,500.00) to be procured under Section 53.9 (b) Negotiated Procurement – Small Value Procurement of 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No.9184;

WHEREAS, the procurement activity has been initiated, the Request for Quotation has been published twice in PhilGEPS from March 17-21, 2022 and the second was on April 4-9, 2022. The RFQ was likewise published in the website of the Procuring Entity;

WHEREAS, a failure of procurement was declared on the first procurement activity for the reason that the HOPE, who reserves the right to reject the offer or the bid, noticed a reasonable and justifiable reason where the award of contract will not redound to the benefit of the SMWD, reference PROC-BCR2022-04-033

WHEREAS, three (3) service providers submitted quotation prior to closing on April 13, 2022. An Abstract of Quotation (AOQ # A2022-106) has been prepared for verification of the offer. The offer of the three (3) service providers did not exceed the Approved Budget for the Contract, to wit:
