THIS AGREEMENT, made this  $\frac{27^{+h}}{}$  day of July 2022 between SANTA. MARIA WATER DISTRICT with principal office address at No. 3 M. de Leon St., Poblacion, Santa Maria, Bulacan (hereinafter called the "Entity") and SCIECOMTECH CORPORATION with principal office address at Cagayan Valley Road, Poblacion, Baliwag, Bulacan (hereinafter called the "Contractor").

WHEREAS, the Entity is desirous that the Contractor execute the project, "SUPPLY OF ADDITIONAL WORK & AUXILIARY MATERIALS AND QUEING SYSTEM FOR THE SMWD" (hereinafter called "the Works")

WHEREAS, the Entity has accepted the Offer/Bid for <u>ONE MILLION SEVEN HUNDRED FIFTY</u> <u>SEVEN THOUSAND NINE HUNDRED SEVENTY NINE AND NINETY SIX CENTAVOS (PhP1,757,979.96)</u> by the Contractor for the execution and completion of such works and the remedying of any defects therein.

## NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- 1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
- 2. The following documents shall be attached, deemed to form, and be read and construed as an integral part of this Contract Agreement, viz:
  - (a) the Proposal/Quotation submitted by the contractor;
  - (b) the Schedule of Requirements
  - (c) the Entity's Notification of Award;
  - (d) the Eligibility Documents submitted;
  - (e) the Performance Security
  - (f) Certification of No Slippage or Delay/Latest Summary of Statement of Work Accomplishment (Original Contract)
- 3. The duration of the contract is for thirty (30) calendar days commencing upon the signing of this contract and the contract location is the new office building of Santa Maria Water District (SMWD) located at No. 301 J.P. Rizal St., Poblacion, Santa Maria, Bulacan.
- 4. In consideration of the payments to be made by the Entity to the Contractor as hereinafter mentioned, the Contractor hereby covenants with the Entity to provide the goods and services and to remedy defects therein in conformity in all respects with the provisions of the Contract.





5. The Entity hereby covenants to pay the Contractor in consideration of the provision of the goods and services and the remedying of defects wherein, the Contract Price or such other sum as may become payable under the provisions of this Contract at the time and in the manner prescribed by this Contract.
