

CONTRACT AGREEMENT CA-2022-08-027

PROJECT: SUPPLY AND DELIVERY OF DESKTOP COMPUTERS, PRINTERS AND OTHER COMPUTER PERIPHERALS FOR THE SANTA MARIA WATER DISTRICT STAFF

THIS AGREEMENT, made this _______ day of August 2022 between **SANTA MARIA WATER DISTRICT** and **XITRIX COMPUTER CORPORATION**

KNOWN ALL MEN BY THESE PRESENTS:

SANTA MARIA WATER DISTRICT, a Government Owned and Controlled Corporation (GOCC) duly organized and existing under and by virtue of Presidential Decree No. 198, as amended, with principal office address at No. 3 M. de Leon St., Poblacion, Santa Maria, Bulacan, represented by its General Manager, ENGR. CARLOS N. SANTOS, JR., duly authorized for this purpose, hereinafter called the ENTITY.

And -

XITRIX COMPUTER CORPORATION., a duly organized and existing entity under and by virtue of the laws of the Republic of the Philippines, with principal office address at No. 23 Detroit St., Cubao, Quezon City represented by its Account Manager, MARLOU B. LIBAO, hereinafter called the **SUPPLIER**.

WITNESSETH:

WHEREAS, in response to the **ENTITY's** Invitation to Bid, the **SUPPLIER** submitted its bid to the Procuring Entity to deliver **SUPPLY AND DELIVERY OF COMPUTER DESKTOPS, PRINTERS AND OTHER COMPUTER PERIPHERALS FOR THE SANTA MARIA WATER DISTRICT STAFF**;

WHEREAS, the bid of the SUPPLIER was the Lowest Calculated and Responsive Bid;

WHEREAS, the **ENTITY** has awarded the Contract to the **SUPPLIER** at the price stipulated in its winning BID of **SEVEN HUNDRED SIXTY EIGHT THOUSAND NINE HUNDRED THIRTY TWO PESOS (PhP768,932.00)** inclusive of all government taxes.

WHEREAS, the Entity is desirous that the Supplier execute the project, "SUPPLY AND DELIVERY OF DESKTOP COMPUTERS, PRINTERS AND OTHER COMPUTER PERIPHERALS FOR THE SANTA MARIA WATER DISTRICT STAFF" (hereinafter called "the Goods") and the Entity has accepted the Bid for SEVEN HUNDRED SIXTY EIGHT THOUSAND NINE HUNDRED THIRTY TWO PESOS (PhP768,932.00) by the Supplier for the supply and delivery of such Goods and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- 1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
- 2. The following documents shall be attached, deemed to form, and be read and construed as part of this Agreement, viz:
 - (a) Contract Agreement;
 - (b) Bidding Documents;





- (c) Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents/statements submitted;
- (d) Certificate of Warranty
- (e) Schedule of Requirements
- (f) the Entity's Notification of Award;
- (g) the Performance Security; and
- (h) Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the Bidding Documents.
- 3. In consideration of the payments to be made by the Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Entity to provide the goods identified in the bidding documents and to remedy defects therein in conformity in all respects with the provisions of the Contract.
- 4. The delivery of the goods is required within fifteen (15) days upon receipt of the approved Purchase Order and the place of delivery is General Services Division's office located in Farmacia Emilia, J. P. Rizal St., Poblacion, Santa Maria, Bulacan.
- 5. The Entity hereby covenants to pay the Supplier in consideration of the provision of the goods and services and the remedying of defects wherein, the Contract Price or such other sum as may become payable under the provisions of this Contract at the time and in the manner prescribed by this Contract.
