**BAC Resolution Recommending Award of contract, "SUPPLY OF SECURITY SERVICES IN VARIOUS SMWD OFFICES FOR THE MONTH OF SEPTEMBER TO DECEMBER 2022" to OMNICHRON SECURITY AGENCY, INC.
Reference No. PB2022-SMWD-S-07-012**

WHEREAS, by virtue of the published invitation to apply for eligibility and to bid in the SMWD website and in the Philippine Government Electronic Procurement System (PhilGEPS), Omnichron Security Agency, Inc. participated in the Public Bidding for the above stated project with an approved budget for the contract of One Million Two Hundred Seventy Five Thousand Five Hundred One Pesos and Twenty Centavos (Php 1,275,501.20);

WHEREAS, on August 3, 2022 at 2:00 PM, a Pre-bid Conference was held to discuss the different aspects of the bidding documents, eligibility, technical and Financial components The pre-bid was attended by three (3) prospective bidders, **Omnichron Security Agency, Inc., Winace Security Agency, Inc., and Militant Security Services;**

WHEREAS, the BAC issued Supplemental/Bid Bulletin No. SBB2022-007 on August 5, 2022 for some clarifications and changes in the published Public Bidding Documents. The bid opening was extended from August 15, 2022 to August 16, 2022 due to the declaration of a Special Non-Working Holiday in the Province of Bulacan;

WHEREAS, only one prospective bidder, the Omnichron Security Agency, Inc., purchased and submitted bidding documents. It was submitted by the authorized representative of the security agency, Mr. Jamieson O. Go on August 16, 2022 at 10:40 AM prior to the closing of submission stated at 12:00 noon. The bid opening started at 1:34PM, Mr. Jamieson O. Go was present and no other observer attended the bid opening despite of the Invitations sent to them;

WHEREAS, the BAC opened the eligibility and technical documents and it was declared that the sole bidder is eligible to bid, thus, the opening of the financial component envelope containing the price proposal immediately follows. The BAC read out the bid, to wit:

4 Guards 12 hours 6 days contract AM at P27,585.03 x 4 months.....	P 441,360.48
6 Guards 12 hours 7 days contract AM/PM @ P33,154.81 x 4 months.....	795,715.44
TOTAL BID.....	P1,237,075.92

WHEREAS, Bid Evaluation was made on August 17, 2022, having no discrepancy in the amount of bid as read and calculated, the sole bidder was declared as the Single Calculated Bid.

WHEREAS, on August 19 and 22, 2022, Post Qualification was done to the sole bidder, the BAC checked and validated all the documents submitted by the bidder. Some additional documents were submitted during the post qualifications stage to comply with all the documentary requirements. As for the eligibility and technical documents, the BAC was convinced that the documents submitted are complete and in order:

WHEREAS, Omnichron Security Agency, Inc., having passed the Post Qualification Evaluation, was declared to be the Single Calculated and Responsive Bidder.
